Watson's Resume: False and Misleading Statements as to Professional Status and Association

The following documents pertain to the misrepresentation by Clovis Watson of his being a member *in good standing* of the professional associations associated with the profession of Public Administration. This issue is related to Watson's criminal and academic fraud related to his false claims to academic degrees and titles he does not possess and association with and academic standing at postsecondary institutions.

The documents provided herein constitute Proof Documents numbers 34-39 being submitted as evidence of criminal fraud and academic dishonesty by Clovis Watson.

This aspect of the case entails Watson's misrepresentation of his affiliation with and membership in the two professional associations for City and County Managers (the ICMA (International City/County Management Association) and the FCCMA (Florida City and County Management Association)). Watson has falsely claimed to be a member of these organizations in good standing.

Watson was and continues to be required, by contract with the City of Alachua and according to the City's Charter, to be "qualified" for the position he holds and to maintain his membership and status as a member in good standing with these associations. The City through this contract pays for his membership in these organizations. However as is revealed herein Watson has violated the Code of Ethics of professional City Managers as required for membership in good standing with these professional associations and is was not a member in good standing when he made reference to these associations in his resumes.

Proof Document 34: Letter from Lee Feldman, President FCCMA, to Watson dated June 29, 2006 (two days prior to Watson applying to become certified to teach at Santa Fe Community College) establishing that he was not a member of either the FCCMA or the ICMA while claiming to be such on his published resumes and in these documents as constituting official public records of the City of Alachua. Alachua's Watson switches parties, blasts Democrats

Alachua County Republicans gained two new allies and candidates for the 2008 elections Friday at an event intended to show the growth of the county party.

Alachua City Manager Clovis Watson and Ward Scott, a Sante Fe Community College professor, traded in their Democratic party registrations for Republican ones and announced their intentions to run at a "switch event" held in downtown Gainesville.

"I'm a man of action and ideas," Watson told a group of a few dozen Republicans who attended the event. "I cannot continue to support a party that uses criticism and calumny as its stock in trade."

"We're turning this county a crimson red," said Watson, who declined to say what office he planned to run for.

The event, attended by Republican Party of Florida Chairwoman Carole Jean Jordan, included speeches honoring the new Republicans and defending Watson in his ongoing legal issues with state House of Representatives candidate Charlie Grapski.s

Scott, a city of Alachua resident, announced his intention for a 2008 rematch against County Commissioner Mike Byerly.

Byerly defeated Scott in a Democratic primary in 2004 after a write-in candidate prevented the race from being put on the general election ballot.

"We're the part of the county that's really carrying the economic development," Scott said, referring to the several distribution centers that are open or planned in the city.

He said his switch to the Republican Party was partially driven by opposition by Democrats to these and other projects, such as a Wal-Mart Supercenter.

Watson's speech, which blasted Democrats and included passionate rallying cries to Republicans, was unusual since city managers and other high-level appointed officials tend to be reserved about their own political views.

Alachua County Public School Superintendent Dan Boyd, for example, came under some criticism recently after donating to the campaigns of members of the School Board.

But Watson said he carries out his duties without regard to an individual's politics and said his position should not preclude him from voicing his own political opinions.

"And I will not always be an appointed official," he said.

Web resume causes flap over old, outdated information

ALACHUA -- An online resume that Alachua City Manager Clovis Watson Jr. hadn't updated in years caught up with him when two organizations pointed out that Watson wasn't a member any more.

"Updating it hasn't been a priority because I haven't been looking for a job," Watson said, laughing.

While outdated, online resumes generally don't stir debate, Watson's did when representatives of two organizations sent a letter to the editor of The Gainesville Sun. That letter was written by the Florida City and County Management Association (FCCMA) president and the International City/County Management Association (ICCMA) executive director.

The letter was sent to the newspaper on the same day a letter was sent to Watson, informing him that his resume on the city of Alachua's Website showed Watson as a current member of the two management associations when, in fact, he wasn't.

The two men said they noticed Watson's online resume after reading a newspaper article in which Watson took a political stance. Members of the FCCMA and the ICCMA subscribe to a code of ethics that "expressly prohibits" political stances, the letter to the editor stated.

Watson said he knew that and had actually resigned from both organizations in November of 2004 precisely because the two organizations' code of ethics prohibit political stances.

"Don't get me wrong," Watson said. "These are wonderful, professional organizations."

But Watson said he needed to resign because his current job requires him to be somewhat political.

"I find that I can more effectively lead this community if I am free to voice my philosophy, my thoughts and my heart-felt feelings," Watson wrote to the FCCMS president. "We cannot truly lead by example if we are restricted from explaining our actions and our visions in the context of politics, since politics is the very essence of government."

Watson said that as soon as the two organizations' representatives pointed out that his resume still showed him as a member, he immediately updated his resume to show that he was a

former member.

But Watson said he questions why the two management associations would not have simply called Watson to point out the outdated resume or at least have waited to see if the resume was updated after the organizations pointed out the error.

Watson said he was particularly concerned with Lee R. Feldman, president of the Florida City and County Management Association. He said Feldman's action of sending a letter to the editor and a letter to Watson on the same day without giving Watson a chance to respond was a political move.

"Apparently, his intent was not simply to inform me of the outdated information on our Website but to publicize his charges in an effort to cast aspersion upon me and indicate that I was acting unethically," Watson wrote to the FCCMA Board of Directors. "I say 'apparently' because there can be no other explanation for his action taken before even receiving my reply. Because my oversight was unintentional and instantly corrected upon receipt of notice, I hardly think it was a matter of unethical behavior, or of trying to misrepresent myself."

Watson also made reference to the letter to the editor being sent after he publicly switched to the Republican Party.

"(The letter to the editor) appears to be a tit-for-tat action designed to do harm to my reputation and character," Watson wrote. "In that regard, I would characterize (Feldman's) actions as political in nature, and, thus, a violation of the bylaws of the groups to which he belongs."
