PROSECUTIVE SUMMARY - CONTINUED

The comforter was outside of the room and was used to carry the DEF's property.

Upon search incident to arrest a green rag was found in the DEF's bag. In the green rag was a glass pipe with burn residue and a small clear bag with white substance (0.80 grams total weight) inside. The substance field tested positive tested for 3, 4-Methylenedioxyvalerone (MDPV.)

Post Miranda the DEF stated someone gave him the key to the room. The DEF could not identify or describe the person. The DEF stated the white substance was "Chinese wax", but it was not his.

I confirmed the DEF's identity using his ASO DOJ photo.
