The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
10/23/2023 10:00

On _____, at _____ (Specifically include facts constituting cause for arrest.)

On the above date and time, while on uniformed patrol of Santa Fe College's northwest campus I responded to an emergency panic alarm set off in Human Resources (building R) on campus.

Upon arrival I spoke with the Victim and Witness about the reason for the alarm activation. VIC was standing in the doorway inside WIT's office when the Suspect arrived and shoved VIC into the office with both hands, forcefully. WIT advised that the SUSPECT then followed the VIC yelling things like "you motherfucker", "i'm going to fuck you up", "you disrespected me", "do it again see what happens". WIT stated SUSPECT was yelling, pointing, and stepped toward the VIC as the VIC walked backwards into a corner inside the office with the VIC holding both his hands up as he was trying to de-escalate any further violence occurring. WIT stated SUSPECT left the area out the front door.

The VIC refused medical attention stating he did not fall to the ground but was shoved with force into the WIT's office. VIC stated just prior to this encounter he was standing on the sidewalk outside the building speaking to a colleague. VIC stated the SUSPECT approached him outside stating "why you in my way" and that he was a "grown man". VIC advised he recognized the SUSPECT as he has had on-going issues with multiple college employees. VIC stated SUSPECT has threatened Santa Fe College Student Life staff and thrown things when he was not given the correct donated food from the food pantry on past occasions so he was familiar with the SUSPECT. VIC stated that he then left the sidewalk area to go to WIT's office for an unrelated conversation. VIC advised that SUSPECT may have followed him or saw where he walked because shortly after he entered the building and pushed him forcefully. VIC advised he was fearful that the SUSPECT would punch him as he was "in his face" and "definitely in striking zone" while SUSPECT was yelling at him. VIC stated he kept his hands up to avoid any further physical violence and stated he was "now concerned for my safety" due to SUSPECTS actions.

Post Miranda, SUSPECT stated he was being "hacked" by individuals at the college and had the emails. SUSPECT also advised that he felt the VIC "disrespected" him by standing intentionally in his way on the sidewalk today. SUSPECT further stated he "stepped to him" like a man and that he "shoved" him in the office but did not punch him at all.

SUSPECT did commit battery by actually and intentionally touching the VIC against his will when he shoved him with his hands forcefully into WIT's office.

Nothing further.
