from the City. He and I discussed the issue for a short time, and I then exited my office to confirm information for Mr. Grapski from the Deputy Clerk. Upon my return, I heard my own voice for a brief moment, as I entered my office door. I then sat back down and noticed a small black case on the table in my office with a blinking red light, and realized I was secretly being recorded.

I then asked Mr. Grapski if he was recording me, to which he replied in the affirmative. I advised Mr. Grapski that it was illegal to record a person without his/her consent, to which he stated that is should be expected since I am a public official. I advised Mr. Grapski that he was incorrect and again stated that his actions were illegal. In a subsequent email from Mr. Grapski (attached), he stated, "...because as a public official - I have a right to record anything you say - because anything you say is deemed to be a public statement."
