**PROSECUTIVE SUMMARY - CONTINUED**

1 a black firearm in his waistband putting her in fear of her life. VIC 1 stated the DEF then reached into her vehicle and attempted to take her keys out of her key ignition, which she stopped him from doing.

VIC 2 stated when he exited the vehicle, he observed the DEF leaning into VIC 1 vehicle. VIC 2 stated when he ran over to the vehicle, the DEF pulled out a black firearm from his waistband and charged the firearm loading a round into the chamber. VIC 2 stated he told the DEF to put the firearm away and there is no need for the firearm, placing VIC 2 in fear for his life. VIC 2 stated when he looked away for a second, the DEF struck him in the head with the black gun. VIC 2 stated both him in the DEF began wrestling for the gun. VIC 2 stated he could not remember how he was able to get the gun away from the DEF. VIC 2 stated once he had possession of firearm he released the magazine from the gun which contained additional rounds in the magazine.

The WIT stated he observed VIC 2 and the DEF began to have a verbal altercation. The WIT stated during the verbal altercation the DEF began striking VIC 2 with the firearm. The WIT stated VIC 2 was able to take the firearm from the DEF and eject the magazine out of the firearm, VIC 2 then handed the firearm to WIT 1. WIT 1 stated he racked the slide back on the firearm and round came out and he placed it on safe.

The incident was recorded on security footage.

When officers made contact the DEF, the firearm was still in the vehicle.

Post Miranda the DEF declined to speak with me about the incident.
