## DEPOSITOR'S UNDERSTANDING

I have read the *Cash Appearance Bail Bond* brochure and I understand **once the case is over:**

- a. If the bond is not forfeited and the defendant or depositor owes money on any court cases in Alachua County, the money will be taken from the cash bond.
- b. The remaining balance, if any, will be mailed back to the depositor in check form. This process takes 2 to 3 weeks.
- c. Any bond money remaining after payment of any money owed by the defendant or depositor on any court case will be returned by check made payable to the depositor at the address listed on the bond. If I move I understand I must notify the Clerk's Office of my correct address.
