female from behind the closed door. The VIC and WIT heard what sounded like loud noises, yelling, and banging sounds during the argument between the DEF and female individual. VIC and WIT stated that the altercation sounded like the DEF was attacking the unknown female/girlfriend.
Following that altercation, the DEF and VIC then got into another verbal argument, in which the VIC told the DEF that he was not welcomed at the house. The VIC stated to the DEF that "he wasn't supposed to be here" and that "he needed to leave and go to his house". The DEF became very aggressive/agitated and began to yell at the VIC stating "he wasn't going anywhere".
The VIC began to get ready for work and went into the bathroom to take a shower. Shortly after stepping into the shower, the DEF barged in aggressively, breaking through the bathroom door and attacked the VIC while she was in the shower. The DEF grabbed the VIC through the shower curtain and shoved her. The DEF then began to push her around the bathroom and struck her several times while stating "He wasn't going anywhere". WIT observed the physical attack between the DEF and the VIC from the hallway.
The DEF continued to push the VIC and began to yell at her saying, "I'm gonna show you what the fuck I'm about", "You ain't shit", "I'll come back and fuck you up". The VIC was able to push past the DEF where she put on her clothes and tried to leave for work. However, the DEF then pushed the WIT out of the apartment and locked the door behind him, leaving himself and the VIC inside alone.
Following this incident, the VIC told the DEF she was going to call police. The DEF

responded saying "He did not care and the she was dead to him". The manner in which the DEF continued to threaten and attack the VIC against her will, created a well-founded fear that the violence he was threatening her with was about to take place. Along with the VIC being fearful for her children and her life upon returning to her home. Since the incident above took place, the VIC has reached out to LEO several times stating that she is "in fear for her life" to return home. To date, the VIC is reluctant to stay at the residence for fear of the DEF showing up to attack her again.

It should be known that the DEF has an extensive juvenile history with LEO, with several felony arrests. The DEF is currently on probation which was ordered on June 22, 2021 for a duration of four years, expiring on June 22, 2024 (Case Report # 01-2020-CF-3206-A). Following the domestic incident that took place, his mother also alleged that he was high during the attack and has been consistently "popping pills" and taking "Molly" over the past several days. The DEF is currently in violation of his probation as he is allowed no new law violations/offenses.
