PROSECUTIVE SUMMARY - CONTINUED

Wit advised that the Def let her into the Vic's apartment claiming it belonged to his uncle. Wit stated that when the Def was confronted by the Vic and then came back into the apartment, he retrieved a firearm she identified as a Draco which is an AK style carbine pistol. Wit stated that the Def showed it to her several times while they were together on this date. The Wit has known the Def for several weeks as positively identified him via a 6 person photo line-up.

The Def was convicted of 2nd Degree Murder and Possession of Firearm by Convicted Felon on 06/20/21.

The Vic stated that she never gave the Def permission to enter her residence and has previously told him he is not welcome there. The Vic stated that she thinks he originally accessed her residence through a window. The Wit stated that the front door was already unlocked when the Def let her in the Vic's residence.
