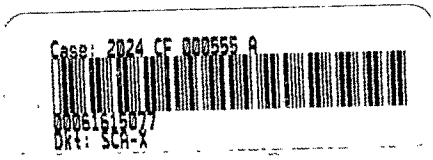

During these investigations, social media data was obtained for the Defendant, KELVIN JAMES ALLEN through a Search Warrant.

After obtaining the data it was reviewed and discovered that on January 23, 2024, the Defendant posted a "Live" video to the account. In the video it is observed filmed in the Pineridge neighborhood. The Defendant is also observed holding a firearm. The video also shows the Defendant removing the magazine of the firearm showing live ammunition in it.



The Defendant was convicted of Second-Degree Murder and Possession of a Firearm by a Convicted Felon on June 20, 2021.
