On 07/13/2023 at 10:45 I was contacted via phone by I had recently spoken to briefly on 07/11/2023 regarding her wanting to make a report related to my recent arrest of a member (Gabriel Hemenez) that attended Ignite Life Center. Ignite Life center is a church located at 404 NW 14th Ave.

stated she attended Ignite summer internship back in July 2021. At the time resided in New York but her church at the time was a sister church to Ignite. s children were invited to travel to Gainesville to attend the church's summer internship program. A to attend in 2018, and 2021. stated when she attended the Summer internship in 2021 she helped cook for the summer program. She stated at that time her daughter P would report to her sexual behaviors that were occurring between the youth at the camp. reported she wa's sexually abused at the 2018 summer internship. stated sometime last year her daughter P reported the incident to GPD (CR 02-23-004972). stated since her daughter last attended the summer camp she has stayed in contact some of the youth that attend the summer program with her. She her daughter P contact with V She stated V disclosed to P that two adult's males named Christian Vargas she had been sexually active and Noel Cruz are actively pursuing younger females for sex. V disclosed to P with both Noel and Christian at Ignite.

Audio from my phone interview with reference the above statements can be reviewed from body worn camera is currently 17 years old and Noel 22 years footage for case report 23-011223. Further investigation revealed V old.

disclosing the incidents between V provided me with text messages between her daughter P and V ` a video of her smiling stating "Christian ejaculated on her shirt". and Noel. stated V sent P talks about an incident between her and sent a voice message record that V sent to P . On the voice note V how often he thought about her and how he missed her. V Noel while at church Noel disclosed to V "I felt cocky" hearing Noel describe how he felt about her. She also stated "I've never had so much fun with a left church together. She and Noel person not just sexually." She continues to state that afterwards Noel and V stated she needed to tell someone. She made out in a parking lot where V performed oral sex on Noel. V stated Noel was 20 and because of his age she couldn't tell anyone else. (I

In this report V 's sexual encounters were mentioned and investigated regarding Christian. On 07/20/2023 I was contacted by V stated she'd like to come and speak with me regarding sexual abuse. On 07/21/2023 at approximately 9:30am I met with V at Gainesville Police Department, Alongside V stated on yesterday she met with an attorney to discuss some incidents that took her mother M V \mathbf{v} place with Christian and Noel while attending Ignite Life Center. The interview with V was recorded on body worn camera under GPD case report 23-0011223. According to V she and Christian begin having sexual intercourse in June 2021. V was 15 years old and Christian was 17 years old. Prior to the sexual intercourse between V and Christian he would text her flirty messages. She stated her and Christian begin casually having sex at the church in the furnace and various location inside the church during church service. She stated Christian would ghost her in between the times they had sex. The two continued having sexual intercourse until November 7,2022. was 16 years old and Christian was 18 years old. She stated her and Christian stopped having sex after her parents found out about the relationship. She stated in November called her mother, after she confided in her daughter P told her mother about the her parents arranged a meeting with Pastor Mark Vega. sexual incidents with Christian and Noel. According to V Lisa Vega, and other Pastors of the church. She stated present during the meeting were the pastors and her parents, Christian, Noel and Noel's dad, Jose Cruz. The meeting took place in November 2022 at Pastor Mark Vega's home. She told everyone at the meeting about her sexual encounters with Christian and Noel. She disclosed how long the relationships lasted. She stated Noel and Christian both admitted in the meeting to having sex with her. V the meeting felt like a time for them to be restored and to put everything behind them. Mark explained jail would not resolve the issue. Mark tried to scare Noel and Christian with Jail. stated she had been friends with Noel for a long time the both of them attended Ignite together. She stated she begin having sexual intercourse with Noel Cruz back in August 2021. At this time V was 15 years old and Noel was 20 years old. She described Noel was a very sexual person. Prior to the two of them having sexual intercourse Noel about his previous sexual relationships with other people. He then begin suggesting to V would text V he wanted to have sex with her. She stated on the first time the two of them had sex Noel drove her home after a youth event. Noel asked V bring him some water. When she went back out to give Noel the water. Noel asked her to get into her car, he drove her around in the parking lot of the apartment complex. Noel started talking to her about his sexual interactions with other "but I know you aren't about it", suggesting she was afraid to have sex. She stated people in the past. He told V Noel was downplaying her and telling her she was not as experienced to having sex with him. She
