PROSECUTIVE SUMMARY - CONTINUED

VIC (while screaming and calling the VIC racial slurs). I witnessed this from a few car lengths behind the VIC's vehicle. The DEF approached the driver side door of VIC's vehicle and attempted to physically fight him. VIC got out of the vehicle to defend himself, and both VIC and DEF engaged in a physical altercation and the DEF continued to batter the VIC until he was stopped by LEO (myself).

Search incident to arrest, a small glass pipe was located in the DEF's backpack which he had on his person. Based off of my training and experience, the small glass pipe appeared to have been used to smoke illegal drugs out of. The pipe contained packed pieces of burned brillo, as well as multiple burn marks inside of the pipe.

The DEF was identified by LEO (DAVID) and VIC. The entire incident was recorded on VIC's cell phone, and LEO also witnessed it.
