**MOTION FOR PRETRIAL DETENTION**

COMES NOW the State of Florida, by and through the undersigned Assistant State Attorney, and moves this honorable court to enter an Order detaining the Defendant in custody pending a final hearing on Pretrial Detention, and sets forth with particularly the grounds and essential facts, as follows:

1. The Defendant has been arrested for an offense for which detention may be ordered under §907.041, Fla. Stat., to wit: Attempted Homicide (Attempted Second Degree Murder).
2. The State will show that there is a substantial probability that the defendant poses the threat of harm to the community. The defendant is presently charged with a dangerous crime, there is a substantial probability that the defendant committed such crime, the factual circumstances of the crime indicate a disregard for the safety of the community, and there are no conditions of release reasonably sufficient to protect the community from the risk of physical harm to persons.
3. The grounds for seeking pretrial detention, as well as essential facts alleged, are contained in the mittimus that was sworn to by Detective Bernal, and is attached as State's Exhibit 1, and is hereby incorporated.

WHEREFORE, the State respectfully moves this honorable court to find that there is probable cause to believe that the Defendant committed the offense, and that the Defendant should be detained in custody pending a final hearing on Pretrial Detention.



Patrol officers responding to the scene conducted a security sweep of the residence and observed a knife in a bedroom near where the VIC was found. Officers also noticed a vehicle parked in the driveway that is registered to the DEF. The vehicle registered to the VIC was missing from the scene.

Affiant called the VIC's emergency contact, who confirmed that the VIC's vehicle was normally located at the residence. He stated the DEF has significant mental health history and that the DEF had reached out to him the prior day advising he was completely out of money and could not pay his bills. There is a pattern of the DEF asking the VIC for money when under financial strain. When the emergency contact got the notice the VIC's life alert had gone off today, he attempted to contact the DEF but the DEF did not answer.

Affiant looked up numerous calls for service involving the DEF and VIC that go back to 2019. In one of these instances, the DEF stabbed himself in the stomach (see CR# 02-23-017274). Officers put out a BOLO for the DEF and the VIC's vehicle.

Officers located the DEF leaving the area of his apartment driving his mother's vehicle and conducted a traffic stop as he was southbound on US Hwy 441. The DEF returned to the station voluntarily to speak to Affiant.

Post-Miranda, the DEF advised he is unemployed and all of his credit cards are maxed out. He also spent all of the money in the VIC's bank account on his drug habit. The DEF

told YA that he last saw his mother this morning, but was initially vague with details. After being told that the VIC survived, the DEF stated "She made it?" and that he pushed her life alert button before he left because otherwise she was going to die. The DEF advised he became angry with the VIC because he is out of money and she refused to buy him a new car. He stated that he "hurt her so bad." The DEF stated that he stabbed the VIC multiple times with a knife he got from the kitchen and that he wanted her to die.

The DEF left the knife in a bedroom and then took the VIC's phone and fled in the VIC's car. The DEF advised he went to his apartment to wash his hands and "smoke crack," then planned to go to Tampa to gamble at the casino there.
