	Legitimate, uncoerced plea bargain.
	The defendant was an accomplice to the offense and was a relatively minor participant in the criminal conduct.

	The offense was committed in an unsophisticated manner and was an isolated incident for which the defendant has shown remorse.
	At the time of the offense the defendant was too young to appreciate the consequences of the OFFENSE.
	The defendant is to be sentenced as a youthful offender.
	The defendant is amenable to the services of a post adjudicatory treatment based drug court program and is otherwise qualified to narticipate in the program
