On 5/10/2023, and again on 5/13/2023, both times at about 1730 hours, the defendant, who is an employee of WalMart at 5700 NW 23rd St, entered into the optical shop and asked the optician, the victim, to show him some frames for glasses he said that he was interested in purchasing. While the victim was reaching for glasses frames, the defendant positioned a cell phone under the dress of the victim, as he bent down to pretend to be looking at lower shelves, or pretended to tie his shoes. The defendant did this several times during each encounter. The defendant also placed the phone on the floor at an angle likely to record up the victim's dress. The defendant also sat at a

desk, across from the victim, and placed his phone in his lap, and on the floor, again, to gain a view up the dress of the victim. The victim became aware of this and reported the incidents to WalMart and WalMart security staff provided in store video to LEO which showed these encounters.  
The victim identified the defendant using his DAVID photo, as she has worked with him for several months.  
The defendant therefore, for the amusement, entertainment, sexual arousal, gratification, or profit of himself, intentionally used an imaging device to secretly view, broadcast, or record under or through the clothing being worn by the victim, without the victim's knowledge and consent, for the purpose of viewing the body of, or the undergarments worn by the victim.
