PROSECUTIVE SUMMARY CONTINUED  
CO-DEF, while in his role as P.E. teacher, made inappropriate comments to [REDACTED] that made her uncomfortable. Specifically, CO-DEF told [REDACTED] that he could be [REDACTED]'s "secret boyfriend" but that they (DEF and [REDACTED]) would have to keep it a secret and that they could not be "open" about the "relationship."  
Affiant's investigation revealed that within hours of receiving [REDACTED]'s report of CO-DEF's inappropriate statements to [REDACTED]. DEF undertook to investigate the report himself without the assistance of or notification to DCF or law enforcement. DEF's investigation included a closed-door meeting between DEF, CO-DEF and [REDACTED] where CO-DEF told [REDACTED] that he did not make any such statements to her and DEF telling [REDACTED] that he believed CO-DEF was telling the truth, "one hundred percent." The very next day DEF would learn, from overhearing CO-DEF speaking to an adult employee that CO-DEF did, in fact, ask [REDACTED] to be in a secret relationship with CO-DEF. [REDACTED] was withdrawn from The School the very next day.  
DEF received a report from an adult employee later that same week (approximately Feb. 22, 2024) about CO-DEF's behavior. The adult employee told DEF that CO-DEF had been acting in a manner toward a middle school girl that made that employee "uncomfortable." Specifically, while monitoring the middle school hallway during standardized testing the adult noticed that CO-DEF was standing outside a classroom staring at VIC. The employee attempted to block CO-DEF's view of the VIC and the CO-DEF would maneuver around the employee in order to continue staring at VIC.  
DEF waited until Feb. 23, 2024 to report the Feb. 20, 2024 incident between CO-DEF and [REDACTED] to DCF. Affiant has learned that DEF's report to DCF contained a conclusion that

PROSECUTIVE SUMMARY - CONTINUED  
CO-DEF engaged in no wrong-doing and that [REDACTED] was in agreement that CO-DEF did not ask to be in a secret relationship with [REDACTED] even though DEF had heard CO-DEF state that he did, in fact, ask [REDACTED] to be his "secret girlfriend" (and/or to be her "secret boyfriend"), although he did so jokingly. Both DEF and CO-DEF have referenced DCF's refusal to investigate the Feb. 20, 2024 incident as an indication that no wrongdoing had taken place.  
Days later, DEF was approached by 3 female 6th graders who requested a meeting with him. VIC was one of the 3 girls. During this meeting the 3 female 6th graders disclosed that CO-behaved inappropriately with all three of the girls individually. The behavior described ranged from inappropriate statements that made them uncomfortable to inappropriate touching while hugging them. DEF did not take any action to shield the girls from CO-DEF. DEF took no action to protect any of the students at The School from CO-DEF; no further reports to DCF or to law enforcement were made by DEF or any member of The School faculty or staff until after CO-DEF was arrested.  
VIC told DEF that on one occasion CO-DEF had whispered "I love you" to her as she walked by him. Shocked and confused she asked him what he had said. VIC recalled CO-DEF looking defeated, upset and hanging his head as he whispered, under his breath something to the effect of, "I said 'I love you'" and walking away and into his office. VIC stated that this made her very uncomfortable and when she heard about CO-DEF asking [REDACTED] to be his girlfriend she felt she needed to report her experience. VIC was joined by 2 other 6th grade girls who reported similar behavior; the 2 girls reported that CO-DEF had been telling them, "I love you" for months. The girls further reported that CO-DEF would say "I love you" to them and expect that they say it back to him.

PROSECUTIVE SUMMARY - CONTINUED

Investigation has revealed that the girls understood that CO-DEF would get "upset" if they did not respond with "I love you" if CO-DEF said "I love you" to one of them. The girls, including VIC, interpreted CO-DEF as getting "upset" at them if they did not visit him during or between classes.

DEF failed to report this information to DCF or law enforcement. As a result of DEF failing to report CO-DEF, CO-DEF remained in his position as P.E. teacher with access to the middle school girls. Investigation has revealed that middle school girls at The School were victimized by CO-DEF after DEF learned of CO-DEF asking [REDACTED] to be his girlfriend and before CO-DEF's employment was terminated.

DEF as Assistant Principal of St. Patrick Interparish School was required to report the lewd and lascivious behavior of CO-DEF as reported to DEF by VIC but failed to do so.
