property. The defendant fell and the three victim's along with several guests pulled him out of the bushes to a clearing and checked on the defendant. The defendant then began punching several guests before having to be restrained by victim 2 in a choke hold. The victims of the battery left prior to LEO arrival and were not able to be located. Once the defendant began to lose consciousness the three victim's carried the defendant back off the property, ensured he was breathing properly and called 911 as they again locked him out of the property.

Shortly after the defendant woke up and traveled around the perimeter fence of the property while stating to the 3 victim's he was going to walk back to his car and retrieve a firearm and return to kill the three of them.

The defendant eventually made his way to an opening in the fence and again entered onto the property and charged the 3 victim's in an attempt to fight them. The three victim's stated the defendant's actions placed them in fear of physical harm and the 3 were able to detain him before he was able to batter them. The defendant continued to try and fight the 3 victim's until victim 1 placed the defendant in a second choke hold until he began to lose consciousness.

The defendant was conscious upon LEO arrival and was still present on the property in LEO presence.

While attempting to interview the defendant he started to assume a fighting pose (puffed

chest, stiffening of his shoulders and arms, and began clenching his fists) while making statements about victim 1. He stated victim 1 was the one and began walking towards victim 1 as if he were about to fight him. The defendant attempted to push past LEO and had to be physically stopped from advancing to victim 1. I placed my hand on the defendant's chest and told him to stop his actions and return to making his statement about the incident. The defendant again tried to push past LEO towards victim 1 in order to fight him. LEO then attempted to detain the defendant in handcuffs and began physically resisting by tensing his arms, pulling away, and twisting his arms while trying to spin around and face LEO. LEO gave multiple commands to stop resisting which he ignored. LEO was able to force the defendant against a nearby fence and force his arms behind his back and apply the handcuffs.
Once the investigation was completed and probable cause was established, the defendant was informed he was under arrest. The defendant refused to enter the rear of the patrol vehicle and had to be physically pushed into the car where he began stiffening his body in an attempt to prevent LEO from placing him in the back seat. He then began forcing his feet into the door jam in order to prevent the door from being shut. The defendant's legs had to be hobbled together which the defendant resisted efforts by kicking his feet towards officers applying the hobble. His feet were able to be hobbled together and forced into the floorboard where his feet were secured via the hobble leash in order to get his lower body secured inside the vehicle. By this time the defendant laid backwards in the seat causing his head to sit where the opposite door would come to rest. The defendant then resisted efforts to sit him up in the car by stiffening his body in order to keep his head in the door jam. Once finally secured in the car, the

defendant had to be transported to the hospital for clearance before being transported to the jail. The defendant was able to place his back against the door and was able to grab the door handle with both hands in an attempt to prevent LEO from being able to open the door. The defendant again ignored commands to stop his actions and the door had to be forced open. Once the door was opened the defendant refused to get out and had to be physically picked up out of the car by several LEO. Due to being hobbled the defendant was placed in a wheelchair which he again resisted efforts of LEO both by stiffening his body then dropping to dead weight causing officers to have to pick him up and physically placed him in the wheelchair. Once inside the hospital the defendant again applied dead weight in an attempt to prevent being moved to a hospital bed for medical evaluation. the defendant again ignored commands to stop his actions and had to be physically picked up and placed into the hospital bed.
