PROSECUTIVE SUMMARY	<p>The DEF was stopped at 400 S Main due to the description that WI1 had described. WI 1 agreed to do a show-up as he stated that he could positively identify the DEF. WI 1 positively identified the DEF via show up stating that "that is 100% him".</p> <p>Post Miranda, the DEF originally denied ever being at the building as he stated that he had gone to Walmart off Archer Road as he had caught the city bus from Rosa Park bus station. The DEF stated that he had then returned to the area and went to Waldo Road.</p> <p>When law enforcement told the DEF that someone positively identified him as the person being at the building, the DEF stated that he had only slept at the building the night prior as he is not the only one who sleeps at the building. The DEF denied ever shattering the window to the building.</p> <p>The building is a government building (GRU) and was unoccupied.</p> <p>The DEF was positively identified via his FL ID.</p>
