PROSECUTIVE SUMMARY - CONTINUED

Ofc Meshes informed me that a citizen at 514 SE 13th Street called CCC to report that he had located ammunition in his backyard and that he had home surveillance footage of a person in his yard at the time of the incident. The footage showed DEF dropping a firearm and picking it back up before continuing to flee on foot southbound. The citizen turned over a 9mm magazine that he had located near his home which was submitted to GPD evidence.

I deployed K9 Stern in the area for gun detection. Stern alerted to a patch of bushes on the property of 588 SE 13th Street. Ofc Meshes was able to see a firearm hanging within the shrubbery. He photographed and collected the gun, a Taurus 9mm (ADA898562) which was reported stolen out of Lake City Police Department. The magazine appeared to be a match to the firearm. The ammunition in the magazine matched the single round found in the firearm.

The firearm was located in a vacant lot with no homes or structures on it. During daylight hours, I was able to see the tall grass pushed down in a southbound direction, indicating that someone had recently moved in that area. The firearm was within feet of this ground disturbance. I was able to confirm with units who had been involved in DEF's arrest that this was the route DEF fled and was tracked by a K-9.

The firearm was in a position that appeared to be the result had DEF thrown it from his person in an attempt to tamper or destroy it as so he would not be found in possession of it at the time of his original arrest.
