Upon arrival and contacting the complaint he stated while working at the same location several of his workers were contacted by Jody Meyer unprovoked, Jody was on his property about 30 feet from the workers. The are hispanic, Jody began calling them illegals and to group of workers including return to their own country. Jody then told that he would get a gun and shoot him, then simulated a gun shooting saying "Bang! Bang!" then rushed inside. believed that Jody was going inside for a gun and retreated from where Jody was and contacted his boss Joseph who called law enforcement. Post Miranda lody admitted to arguing with the group of workers including and calling them illegals however denied any threats. Several witnesses in the group of workers filled out sworn statements that coincides statement of Jody threatening harm.
