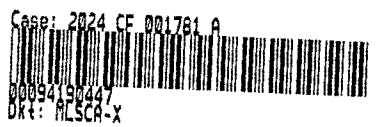

VIC stated that while she was at work, the DEF started sending numerous threatening text messages stating he would kill the VIC.

These are the text messages sent by the DEF to the VIC.

VIC advised that between 1330 and 1409hrs, DEF sent a series of threatening text messages to her cellphone threatening to kill her.

The text messages start at approximately 1402hrs.

Mitchell listed as "Bro" on the text screen. "I'm going to kill you".  
VIC responded: "I'm at work there is nothing I can do about it right now. Patient care is more important than your clothes."

Mitchell texted back: "I'm going to kill you."  
VIC responded back: Well now I don't feel safe letting you come pick up your stuff at all today. You can buy whatever you need for the week."

Mitchell texted back: "You shouldn't feel safe, I'm going to kill you."  
[REDACTED] (Mother of both VIC and DEF) texted to both: Mitchell stop it. [REDACTED] he needs to get his things and then return your key. This has to occur today when [REDACTED] gets a chance."

**PROSECUTIVE SUMMARY - CONTINUED**

At approximately 1409hrs, DEF text the following to VIC. "Don't try and fuck with me [REDACTED]. You re wrong here. And if you threaten me ever again, I'll knock you down and strangle the oxygen out of your windpipes and look at you on your last breath and say fuck you and I'll be glad it happened."

VIC then advised at approximately 1353hrs, DEF came back and was in the back yard. While in the back yard, VIC stated that DEF took down the security camera. VIC stated that she did not observe DEF's face on the camera but did observe his hand reach up and disable the camera. VIC stated that the camera is no longer on scene at her house. VIC stated the camera is an outdoor Arlo security camera with an approximate cost of \$75.00.

VIC then called LEO back to advice that the DEF had sent another series of threatening text messages. Those messages are as follows:

DEF sent the following text message to VIC: "I am in southern Georgia, my phone is dead and I have no charger or service. I am coming to MN. I have quit Lowe's. I will not return to Florida. I will kill [REDACTED] later on. Mark my words, I will kill her."

"My phone is about to die since [REDACTED] stole my charger. And my eye contacts. And all of my clothes. And my laptop. And my laptop charger. And my laundry basket. And \$8,000 I'm due through June from Lowe's."

"If I do not receive any of this, I will kill [REDACTED] and her dogs, dogs first. I know
