PROSECUTIVE SUMMARY
CONTINUED
Incident #1- 24-3504- March 2, 2024 at 2302 HRS
On Monday 3-4-2024, the front glass doors of the Old Library building were found smashed out by city hall security. There was a piece of slate tile inside the building and a folded up note was left inside the lobby area. The note stated the following: "Keep giving all our jobs to the blacks and hispanics. Retribution is coming. Trump 2024. DEI (encircled with the don't symbol)." Video surveillance revealed the DEF (unknown identity at the time) walked in from the neighborhood north of city hall. He walked through the north side parking lot after he put on a hat, sunglasses, and raised up his red jacket hood. The DEF was wearing distinct white sneakers, navy blue pants, and a red hooded jacket/sweatshirt. He appeared to be middle aged, tall (6-00+), and thin build. The DEF walked up to the doors, threw the tile through the doors and eventually left the note inside the lobby. He quickly runs away from the door and takes the same path back into the neighborhood north of city hall. At the time, the identity of the DEF was unknown. At the time, a suspect vehicle was not known. The damage to the doors was estimated at \$2500.
Incident #2 - 24-4212- March 17, 2024 at 2235 HRS
On March 18th at 1430 HRS, city cleaning staff noticed a broken window on the south side of the city hall building on a second floor office. At the time, the time range for when the damage occurred was sometime between the morning of March 13 and the early afternoon of March 18. It appears a chunk of brick was thrown through the window. There was no note left in this incident and there is no video showing this area of the building. At the time, the person who threw the video was unknown as well as a vehicle

due to the large time frame. The damage to the window was estimated at \$8312.

Incident #3- 24-4670- March 26, 2024 at 2108 HRS

On March 27, 2024, city staff discovered a north office window smashed by multiple large rocks. The office is normally occupied by City of Gainesville Mayor Harvey Ward who is an elected official for the city. A folded up note was left in the office along with the rocks used to break the window. The damage to the exterior window, the interior wall, and other items in the office was estimated at \$8000. The content of this note is as follows: "Mr Ward, You insult our intelligence, and we have had enough. You continue to talk up DEI, all the while we've had 2 white young people killed by blacks in the last month. We want the DEI program fully shut down. You won't listen to our words, so we now speak in the language of our January 6th brothers and sisters. RIP Andy Gil. RIP Caleb Frier. DEI (encircled by don't sign). And no I am not racist. I'm simply tired of us whites having to take it on the chin. Those days are over and anyways, people like me do not care about being called racist! (you called me that a meeting.) Don't make me turn this place into the Alfred P Murrah building." Video surveillance was reviewed and it appears just prior to the rocks being thrown, the DEF is seen arriving in a vehicle in the neighborhood north of city hall (300 NE 2nd ST). The DEF walks towards city hall wearing the same red hooded jacket, a hat, and khaki pants. The DEF is seen walking towards the area where the window is located, then runs north immediately to his vehicle and leaves the area. Further review of the surveillance video reveals the vehicle driven by the DEF is a light green Kia Soul. The DEF was actually observed scoping out the area on foot and in his vehicle about 30 minutes prior to the window being broken.

PROSECUTIVE SUMMARY - CONTINUED
The content of the note left by the DEF constitutes "Corruption by Threat against public servant " (FSS 832.021). The DEF threatens unlawful harm ("Don't make me turn this place into the Alfred P Murrah building") to a Public Servant ("Mr Ward") to influence the performance of any act or omission the person believes to be within the discretion of the public servant ("We want the DEI program fully shut down").

(Alfred E Murrah building is a federal building Timothy McVeigh detonated an explosive device at on April 19, 1995)

Through the use of multiple investigative tools and techniques, coupled with the video footage from City Hall, the DEF was identified as the person responsible for the previously mentioned acts. The following was determined:

The DEF's vehicle is registered to him and his father who reside at [REDACTED] TERR, Gainesville, FL. Utilizing the various automatic license plate readers located throughout the city, we identified the DEF's vehicle and determined the it mostly hits the tag readers during the daytime hours. The DEF's vehicle hits off the tag reader at 3400 W University Ave once again heading east towards City Hall (downtown) at 2226 HRS. The VEH is seen slowing at E 3rd ST as if to turn north onto NE 3rd ST which would put him near the window that was broken by the piece of brick. foot from the parking lot north of NE 2nd AVE. The DEF also gets back in his vehicle to circle the area around city hall. He eventually commits the act just after 2107 HRS and leaves the area at 2110 HRS. It is unknown where he goes before he starts to show the same exit path westbound on Archer Rd at 2248 HRS (Archer/SW 23rd DR) and 2254 HRS (Archer/Center DR). Once again, the DEF hits the tag reader as he exits off I75/W Newberry RD at 2257 HRS as he returns back to the direction of his parent's house.
Research into the DEF revealed he is a registered republican in Alachua County ("Trump 2024") . He has had multiple incidents/contacts with the police since the early 2000s. He has a history of drug and especially alcohol related incidents. One such incident with University of FL PD (CR# UFPD 15-2457) from 2015 involved him being intoxicated and speaking incoherently about gang violence, current events in Chicago, and other recent topics that were upsetting him. The DEF was taken into custody under a Baker Act during that incident in 2015.
I looked at the note left by the DEF on 3-26-2024 since it had the most writing on it. I noticed in comparing the upper case "D" in "DEI" , the letter "D" is written in cursive in the same way he signs his name (James Dewar) on his FL DL.
On Tuesday 4-16-2024 at 1100 HRS, the DEF's father was interviewed at GPD. He will be referred to as WIT. The WIT was not provided with details of the note left by the DEF prior to this interview. He was only advised the DEF was the suspect in the investigation and he made statements which were threatening towards a city department. The WIT was asked to provide a background on the DEF. Of significance, WIT discussed the long history of alcohol, Adderall, and gambling issues he has had for the past 20+

years. The DEF has been in and out of sobriety for years and in a number of rehab programs. Based on the timeline provided by WIT, the DEF left town shortly after the incident on 3-26-2024. The DEF flew to Vegas for a couple of weeks and then headed to Boise, ID to seek treatment. This would make sense since there were no tag reads for the vehicle for several days and the criminal mischief incidents stopped at City Hall after 3-26-2024. Surveillance at the house also showed the vehicle being parked at the house for a number of days in the same spot. WIT provided details about the DEF which I felt showed consistent patterns of behavior/thinking that was mentioned in the note:

1. When he drinks, he gets angry and will usually say or write things to his father that he wishes he would die and he is a "liberal embarrassment." He will text these messages to the WIT.
2. When he was in Vegas, the DEF stated to the WIT "someone should drop a nuclear bomb on the gambling institutions" because they are ruining peoples lives.
3. The DEF has spoken about his issues with DIVERSITY and racial hate.
4. The DEF complained about "he can't get a job and if he was black, they would be throwing jobs at him." WIT confirmed he knew for sure, that statement came from the DEF in the past.
5. The DEF was [REDACTED].
6. After being shown the notes and him seeing the names of the two young white males who were killed by black males (Andy Gil and Caleb Frier), the WIT recalled the DEF talking about two local white kids being killed by blacks and asked him (the WIT) "How many will it take" for him (the WIT) to get upset about it. The DEF asked the WIT, "four?"
7. The WIT estimated the DEF was at the Gainesville house for approximately 2-3 weeks before heading back west to Idaho.

8. The DEF has issues getting a job and has resorted to getting food delivery jobs in the past because he usually will not pass a background. The DEF was not working while he was here in Gainesville, but he did put applications in at other places.
9. The DEF is the only person who uses the green Kia Soul registered to both of them.
10. The WIT does not allow the DEF to drink at the house and it seems every 7-10 days, the DEF has "a spell" and he will leave the house. The WIT will take him to a Motel 6 near Applebees when he gets out of hand.
11. When I asked the WIT about what his thoughts were about the written statement about committing violence, the WIT recalls the DEF making statements, but not ever following through.
12. When shown the best video of the DEF walking up to the glass doors, the WIT said he recognized the shoes on the DEF as shoes worn by the suspect. When asked about the red jacket, the WIT advised he believes he has seen the DEF wear that jacket in the past. Due to the face being obscured, the WIT could not say it was the DEF for certain. He did agree the person on video was 6-1 or 6-2 which was consistent with the DEF. The WIT advised he could not say the person on the video was definitely not the DEF. The DEF said the shoes stick out to most for him as far as clothing.
13. When the WIT read the note and there was the reference to the Oklahoma City bombing, the WIT advised the DEF has been talking about the same bombing for the past 15 years. The WIT assured us the DEF has never had a weapon in the past. The WIT said he could see the DEF picking up rocks and throwing it through a window, as in this case. The WIT advised the DEF even made statement in the past along the line of "I don't have guns... I don't have bombs...but I have rocks."
14. The DEF has no friends and he seems to have alienated everyone around him.

On April 17, 2024, I called the DEF at the number provided by the WIT. After leaving a message for him to call me back. I called the DEF back after I missed his call. Upon speaking to the DEF, I asked him to tell me about his timeline for the past month, prior to him leaving. I assumed the DEF would be aware of some of the details of the incident since we asked the WIT to speak to the DEF to see if we could talk as a group over the phone. Upon speaking with the DEF, he advised the following:

I asked the DEF why he might think we would want to talk to him, of all people, about the vandalism at City Hall. The DEF advised he has an issue with Adderall and will sometimes go downtown. The DEF advised he will go downtown, park somewhere, and just walk around "taking in the environment." The DEF thought we may have seen him or his car on video and this would be the explanation why. The DEF admitted he would also be drinking and taking Adderall. The DEF admitted to walking around downtown for maybe an hour or two when he goes there. The DEF admitted to going downtown a couple of times during the past month. The DEF advised he will usually park in free parking on the street. The DEF advised he will sometimes stop in some place and get a beer. When asked what bar he may frequent, he advised he would not go to a bar to drink. The DEF seemed to stress to me that he was on Adderall and alcohol which would explain this behavior. The DEF could not advise where exactly he did park but it could be anywhere in a 10 block area. The DEF advised when he goes downtown, he is alone and does not meet up with anyone. The DEF advised he would eventually go back home after going downtown to sleep. The DEF advised he would usually take University Ave or Archer Rd in order to get home, depending on traffic. The DEF would also take I75 on his way home. The DEF advised he did not loan his vehicle to anyone during the month and only he and the WIT (occasionally) use it.

The DEF advised he was in Gainesville for about a month and he flew out to Vegas about 3 weeks ago. The DEF advised he left Gainesville because things were not working out at the house with his parents. The DEF admitted he did apply for jobs here in Gainesville with no luck (Publix, Dollar General, Hungry Panda). The DEF advised he was get getting irritated at home and that's why his parent sent him away. The DEF advised his Vegas trip was not good because he has a gambling problem and he blew his money (consistent with the WITs statement). When asked direct questions about the incident at city hall, the DEF advised he had nothing to do with it and denied any involvement. The DEF refused to answer any other questions at one point.
WIT one later confirmed he purchased a ticket for the DEF to fly from the Gainesville Airport to Las Vegas, NV on American Airlines. The DEF advised he dropped the DEF off at the airport at 1100 HRS on 3-29-2024. On 5-1-2024, video footage was reviewed at the Gainesville Airport which confirmed the DEF was dropped off at the front of the airport in the WIT's green colored Audi SUV. The DEF exited the passanger side of the vehicle and was wearing a red hooded sweatshirt/jacket which appeared to match the one in the video from City Hall. The DEF was also wearing distinct white sneakers and what appeared to be navy blue pants which also appear to match the clothing on video from City Hall on March 2, 2024.
Based on the above investigative findings, the DEF is responsible for damaging the city hall windows and doors on all three incidents which caused a total of \$18,812 in damages. The DEF is responsible for leaving the notes left behind in both incidents. The content of the notes is consistent with statements the DEF has made to the WIT in the

past. The content of the notes are consistent with issues the DEF is currently experiencing in his personal life. The WIT advised he recognized the shoes and jacket the DEF wore in one of the videos. The DEF's physical build matches the person on video as well. The DEF admits to be being in downtown Gainesville, parking and walking around downtown on at least two occasions during the month he was in Gainesville. The DEF also admitted to taking the same exit route on two of these occasions. The Criminal mischief incidents began occurring around the time the DEF returned to Gainesville and have now ceased once the DEF left town for Las Vegas, NV. The footage from the Gainesville Airport from March 29 shows the DEF wearing nearly the same clothing he wore on 3-2-2024, outside of City Hall. Contained within the note left on 3-26-2024, the DEF made an unlawful threat to an elected official (Mayor Harvey Ward) in order to influence the performance of any act or omission the person believes to be within the discretion of the public servant. Requesting the shutting down the Dept of Equity and Inclusion (DEI) would fall under the element of this statute.
The DEF was sworn complained for felony criminal mischief and Corruption by threat against public servant. The DEF was identified by his FL DL.
