their relationship in October of 2023. Vic1 explained Def1's behavior worsened, calling and messaging her against her will with an extremely disturbing incident occurring 12/1/24.

In regards to the incident on 12/1/24 Vic1 stated the following:

During the evening of the above date, Def1 showed up at her apartment unannounced and not invited. Vic1 advised she heard a knock at the front door and went to answer it. At the time Vic1 did not know who was at the door, so she cracked it open slightly to see who it was. Vic1 advised Def1 then threw himself against the door, forcing it open; grabbing her, and then throwing her to the floor. Def1 then rushed past her to the stairs. Vic1 stated the person she was dating was upstairs, and unaware of the situation. Vic1 stated she believed Def1 was watching her, and chose to force his way into the apartment while the person she was currently dating was inside for unknown reasons. Vic1 recalled being terrified and going to the kitchen to take cover behind the cabinets while screaming.

Vic1 initially advised her screams alerted her roommate, Wit1, who came out of her room, and met Def1 at the top of the stairs. When I spoke with Vic1 after uniformed patrol, she stated that she doesn't actually remember exactly where Wit1 was, just that she had appeared. According to Vic1, her roommate ordered Def1 out of the apartment and Def1 seemed surprised to encounter Vic1's roommate. Vic1 advised shortly after meeting her roommate at the top of the stairs, Def1 left the apartment. Vic1 stated Def1 was unable to get to the new person she seeing due to her roommates intervention, and did not know what would have happened if her roommate had not intervened.

Vic1 stated, she was concerned because she did not know how Def1 would have known she was home.

PROSECUTIVE SUMMARY
At a later date from the initial report, I made contact with Wit1. Wit1 stated the following for the 12/1/24 incident:

Wit1 stated she had just arrived home from work, parked at the rear of her residence (where the back patio and a secondary entrance was), with her vehicle off and scrolling her phone. During this, Wit1 saw Def1 arrive in the parking lot. Def1 was walking back and forth from the back and front doors. Wit1 was going to get out of her vehicle until noticing how agitated Def1 was. When Def1 was out of view long enough Wit1 thought he had left and went to the back door to enter inside. When Wit1 opened the door she watched as Vic1 had the front door slightly cracked open, Def1 then shove the door open, grabbing Vic1, throwing her onto the ground, and then immediately running upstairs. Wit1 ran over to Vic1 to make sure she was okay, and then moved her to the kitchen for safety. Wit1 heard yelling from upstairs and went to hopefully diffuse the situation. Upstairs Wit1 found Def1 yelling at the other male, posturing, and preparing to fight. Wit1 interrupted them and told them both to leave. The other male left immediately, while Def1 was still volatile. Wit1 focused Def1 onto her, which calmed Def1 down. Wit1 then did/said whatever she could till Def1 agreed to leave. While Wit1 was walking Def1 out of the residence, he saw Vic1 and began to yell at her. Wit1 stopped him and brought him outside. After she was sure, or at least felt certain, Def1 was gone she and Vic1 stayed on the back patio for the remainder of the night. Wit1 stated they were both in immense fear that Def1 may return and could not sleep.

PROSECUTIVE SUMMARY CONTINUED

Wit1 remembers the details of this event well as she also texted her boyfriend soon after the incident. Wit1 showed me the messages which aligned with what she had told me.

On 12/16/23, Vic1 messaged a mutual party between Def1 and her. She stated the following:

Vic1: "I just want to let you know that I keep getting excessive messages from [Def1]. He shows up to me apartment. He's borderline harassing me. My roommate is afraid of him. I do not want to file a police report. Please talk to him bc [because] I do not feel safe."

Vic1: "Just please talk to him because I still care about [Def1], but this behavior is extremely scary. I do not want anything to escalate, and I hope that [Def1] feels the same."

Vic1 told patrol after this incident, she wanted nothing more to do with Def1 and ignored his calls and messages. Vic1 explained Def1 began calling her from app generated numbers and from blocked numbers as a way to force contact with her by deception. Vic1 explained she did her best to ignore the contact from Def1 via blocked numbers, App generated numbers, and various social media platforms. Vic1 explained she went to great length to block the calls and social media contact from Def1 for the next several months. Vic1 stated she hoped if she ignored Def1, he would go away. However, as the contact continued into the New Year, it was clear to her Def1 would keep contacting her.

Vic1 recalled telling Def1 unequivocally in November 2023 to leave her alone, and she

did not want any further contact from him. Vic1 advised Def1 completely disregarded her order to leave her alone and not only continued to call, email, message on social media, but found her friends and family on social media and attempted to friend and contact them. In addition to contacting her friends and family Vic1 advised she believed Def1 was also monitoring her somehow and possibly watching her.
Vic1 described another incident in April during which she went out with a friend named E [REDACTED]. While she was out with E [REDACTED], Vic1 advised she received messages from Def1 asking her who was E [REDACTED]. Vic1 explained this was disturbing because she could not account for how Def1 even knew of E [REDACTED] or that she was with him. This incident corroborated that Def1 was monitoring Vic1 and her movements.
Vic1 described how Def1 made a friend request to her friend A [REDACTED] on social media, and even attempted to friend her mother 8/13 (the same day as the initial report). Vic1 explained this was significant because as she continued to block Def1's access to her from her social media accounts, he started to reach out to her friends/family on social media in an attempt to reacquire her. Vic1 explained this is an ongoing pattern of unwanted contact and manipulation from Def1 which still causes her fear and anxiety almost a year from their break up and her telling her Def1 to leave her alone.
Vic1 explained this prolonged experience with Def1 causes her anxiety and distress over the disruption to her life, in addition to the fear of escalation which Def1 has already demonstrated. Vic1 stated Def1's continued repeated unwanted contact, and unjustified possessiveness over her makes her fearful for the future, and fearful a lasting resolution is not possible even with law enforcement intervention.

Def1: "VIC1 STOP...do not do this. Please."
Def1: "I`m sorry I`m sorry I`m sorry"
Def1: "Please don`t ruin my life"
Def1: "Please don`t press charges I`m sorry FUCK"
Def1: "I have school and work and shit I have to do Please Vic1 I`m sorry. I just wanted to talk and I`m moving so it don`t matter Please I`m sorry goodbye."
Def1: "I wish I never met you "
Def1: "Now my life is ruined"
Def1`s message was concerning for several reasons: It proved he was maintaining some form of surveillance on Vic1 physically or remote, and continuing to contact her against her will. Def1 took no responsibility for his actions, and had the additional audacity to blame Vic1 for the emotional impact on him for the consequences for his own actions.
Def1`s repeated behavior over the past several months represents an ongoing pattern of malicious conduct which is goal oriented and clearly directed at Vic1. There is no legitimate justifiable purpose to Def1`s harmful behavior. Def1 continues to harm Vic1 with the stress, anxiety, uncertainty, and fear over this situation. Def1s blatant
