Having considered all available relevant information necessary to determine the conditions of Defendant's release, and finding probable cause except as indicated below, it is

- The State Attorney shall provide additional evidence to the Court within 72 hours to establish probable cause as to the charge(s) _____


NOW THEREFORE it is ORDERED that the Public Defender is appointed to represent the above named defendant/child.

This appointment shall be revisited if, after filing an application/affidavit of indigent status, the clerk determines that the defendant/child is not indigent.


