the child. VIC 1 stated she looked outside of the window of the residence and observed the DEF look at her directly then fired approximately 6 shots in the air.

VIC 2 and VIC 3 stated the DEF came to the residence approximately 3 times throughout the day demanding to see VIC 1. VIC 3 stated she opened the resident door the second occasion and the DEF stated "bring me the baby" and VIC 3 stated "NO". VIC 3 stated VIC 2 was standing with her at the door when the DEF stated "yall burning bridges and yall going to lose everything". VIC 2 and VIC 3 stated the DEF proceeded by lifting his shirt and showing them a black gun on his waist band area. VIC 2 and VIC 3 stated they were in fear for their life and feared the DEF would do something to them. VIC 2 stated she immediately closed the door and called LEO.

VIC 2 and VIC 3 stated that they were inside when the DEF showed up again for a 3rd time and heard the gun shots. VIC 2 stated she looked through the window and observed the DEF running and leaving in VIC 1's vehicle prior to LEO arrival.

VIC 3 stated every occasion that the DEF showed up to the residence VIC 1 was locked in the bedroom. VIC 1 locked herself with her child in the bedroom to prevent the DEF from getting to her due to his aggressiveness. VIC 1 also had been physically battered by the DEF earlier in the day in ASO jurisdiction, where the DEF also stole VIC 1's vehicle (CR 24-6938).

The DEF was positively identified by VIC 1 on scene by RMS photo.

I did not make contact with the DEF due to he left the scene prior to LEO arrival. The DEF was located by ASO who took him into custody for Domestic Battery and Grand Theft
