Probable Cause

On 8/11/2024, ASO was requested by Gainesville Police Department to attempt to locate a black Ford Fusion (FL Tag RLWW23) possibly involved in an armed disturbance investigation. ASO was informed the vehicle was being reported stolen as well.

ASO conducted a high-risk traffic stop on the vehicle in the area of 8008 NW 31st Ave. The defendant, JOEL FOSTER exited the vehicle from the driver's seat and was the sole occupant. JOEL FOSTER was immediately searched following his exit of the vehicle. An empty handgun holster was located in the area of JOEL FOSTER'S appendix. A plastic bag containing a white rock-like substance was located in JOEL FOSTER'S pants pocket. This substance weighed approximately 30.3 grams including bag weight and field tested presumptive positive for the properties of MDPV.

ASO conducted a search of the vehicle and located a 9mm handgun with a modified "Extended" magazine, SKS rifle with a modified "Extended" magazine, two boxes of 9mm jacketed hallow point bullets and approximately 19 grams of marijuana including bag weight.

Post-Miranda JOEL FOSTER alleged he had permission to operate the vehicle and was unsure how it was being reported stolen. When asked about the MDPV located on his person JOEL FOSTER stated, "I smoke Molly a lot" and planned to partake in the narcotics with a group of people. JOEL FOSTER stated he does not sell narcotics and only uses them for himself. JOEL FOSTER stated he was in possession of the firearms because he planned to go target shooting with a friend.

The following is transferred probable cause from Deputy Lamar in reference to the domestic battery and stolen vehicle portion of this investigation.

The VICTIM and the DEFENDANT have a newborn child together and have been in an intimate relationship with each other for over a year making the incident between them domestic in nature.

On August 10th, 2024 at or about 1230 hours at 8203 NW 31st Avenue in Gainesville, FL (Santa Fe Oaks Apartments) located in the jurisdiction of Alachua County, the above named defendant did commit battery and grand theft of a motor vehicle upon the victim. The defendant, Joel Foster, did intentionally touch or strike the victim, against her will. The defendant also took the victim's vehicle without her permission to either temporarily or permanently deprive the victim of any benefit of said vehicle.

On the listed date and time, the DEFENDANT and the VICTIM were in an argument with each other regarding the DEFENDANT's ex-girlfriend and the paternity of their newborn son. As the argument grew more aggressive the VICTIM
