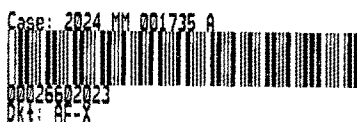

Probable Cause

On the above date and time, I responded to [REDACTED] in reference to a Domestic Battery. The complainant, [REDACTED] (Victim), contacted ACSO-CCC with information regarding her boyfriend, Richard Hymes (Defendant), had hit her several times, destroyed things in the house, and was currently outside looking for a gun.

The Victim and Defendant have a child in common and reside together at the listed location as if a family making this incident Domestic in nature.

Upon arrival, I met with the Defendant who exited a car, and sat on the trunk. I asked the Defendant if he had any weapons on him, and he stated something to the effect of "I only got a big attitude on me". I asked the Defendant to step down from the trunk, and he began reaching into his pants. I deployed my agency issued firearm, and gave verbal commands for the Defendant to remove his hands from his pockets, and get on the ground. The Defendant refused several verbal commands, and it took two deputies to place the Defendant into handcuffs, as he continually resisted and obstructed our efforts.

Deputies spoke with the Victim who advised the following information. The Defendant and Victim were arguing about infidelity. The Defendant got into her face and began walking closer and closer to her until she was against a wall and could not move any further away to get away. The Victim pushed the Defendant back to be able to get away, and the Defendant began punching the Victim numerous times in the head. The Victim had slight red marks on her face, and explained that the majority of the punches were under her hair.

I attempted to read the Defendant his Miranda Rights from an agency prepared text, and the Defendant continued to talk over me and stated he did not wish to speak with us.

An ACSO Teletype query of the Defendant's criminal history revealed no prior battery convictions.

The Defendant is being charged with Battery (Domestic) and Resisting without violence.
