The VIC recently blocked the DEF from phone calls and social media which led to malicious and threatening phone calls and messages. Between 6/13 - 6/14, the DEF demanded to see the VIC and repetitively harassed her with 5 messages from his cell phone 723-1012 to her cell phone [REDACTED] which stated "I'll see you," "I'm following you," "it's urgent," and later that night "either you call me or I'm coming over, at

this point IDC (abbrv. for I Don't Care)" which she reported to LEO (CR #23-009511).
Today on 6/15 as the VIC and the WIT (victim's mother) walked out to their vehicle in the parking lot, the DEF was waiting for them in front of the residence in his known white Dodge Charger (FL tag #L6ITF). While the VIC was getting into her car, the DEF messaged her at 1946hrs and sent her a screenshot pin of his location next to her. The VIC panicked, looked around, and saw the DEF's car nearby. This caused the VIC to reasonably fear for her safety and the WIT drove them away from the residence in the VIC's own blue [REDACTED] (FL tag # [REDACTED]). The VIC and WIT observed the DEF drive after them across town in the pouring rain and saw him recklessly run a red light as they attempted to get away. They drove through various Butler Plaza parking lots until they could not see DEF's car any longer and pulled over to meet LEO at 3404 SW Archer Rd (CVS).
While I was on scene, the VIC showed me the DEF continued to text her a total of 10 repetitive messages and stated at 2006hrs, "that was fun I'll see you later," "until u respond, I'm going to camp out at your residence you won't know I'm there but I'll definitely let you know," "it's obvious I still love u, why you dodging me," and "I'm staying in [REDACTED] tonight." The DEF continued to call the VIC with missed phone calls and sent audio recordings. Then at 2114hrs, the DEF texted the victim "I know where you at, I'm coming you can't hide from me" and at 2127hrs "I'll see you at work in the morning."
The DEF's actions over the past 3 days of sending 15 malicious and threatening messages and physically showing up at the VIC's home coupled with following after her vehicle
