On 8/20/2024 at approximately 2245 hours, a traffic stop was conducted on a vehicle that Keith Gerard Miles was the front seat passenger of; he will be referred to as the DEFENDANT herein.

The DEFENDANT exited the vehicle on his own; without being instructed to do so. I gave a verbal command for the DEFENDANT to remain inside the vehicle; he refused and fled on foot. At this time, a foot pursuit was initiated and I gave a lawful command for the DEFENDANT to surrender; he refused and continued to run. I then deployed my TASER at the DEFENDANT which achieved the desired effect to arrest the DEFENDANT. While detaining the DEFENDANT, he spontaneously uttered that he ran because he has an active warrant.

A query of the DEFENDANT via FCIC/NCIC revealed him to be actively wanted out of Alachua County (see case number 012024CF002530A) in reference to DOMESTIC AGGRAVATED STALKING, DOMESTIC FELONY BATTERY, AND FELONY CRIMINAL MISCHIEF issued on 7/29/2024 by Judge Colaw.

Based on the circumstances, law enforcement was engaged in the execution of legal process and were legally authorized to do so. Therefore, the DEFENDANT is being charged with one count of RESISTING WITHOUT VIOLENCE.


