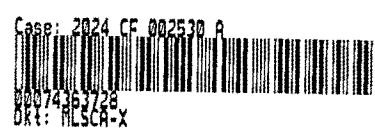

her vehicle multiple times, causing visible dents, deformations, and scratches to the vehicle in excess of \$1000 of damage.

PROSECUTIVE SUMMARY CONTINUED
WIT stated they saw DEF standing over VIC on the ground. WIT observed VIC get off the ground, and saw DEF hit VIC in the face in a "clothesline" style, using the inside of his arm to knock VIC to the ground. WIT stated that VIC got up, and DEF struck VIC in the face at least one more time.

DEF left the area of the incident, but returned a short while later and made credible threats against VIC, including: "Your life ain't yours", "I own you", and "Your life ends today" while reaching towards his waistband as if he had a weapon. VIC stated that she was fearful that DEF was going to try to kill her, and that DEF is known to be in possession of a firearm. DEF willfully and repeatedly harassed VIC causing undue emotional distress and fear for her safety.

DEF and VIC have children in common, and have lived as a family in the past.

DEF positively identified VIC via his RMS photo.

DEF has prior convictions of Domestic Battery and violation of pretrial release conditions for Domestic Violence (Ref UCN 012009MM005959XXX) and Carrying a concealed firearm (Ref UCN 012002CF003011XXX).
