she was certain that he possessed a gun at the time. The VICTIM explained that the DEFENDANT always carried a small, silver handgun in his pocket which had an attached clip for securing it in place, similar to the pocket clip featured on many pocket knives. Additionally, the VICTIM described the DEFENDANT presenting the firearm on several previous occasions whenever they would argue and had even gone so far as to remove the magazine and show her an individual bullet.

As the night progressed, the DEFENDANT continued his attack on the VICTIM. After threatening to kill the VICTIM, the DEFENDANT then attempted to choke her. The VICTIM described the DEFENDANT using his forearm in a bar across her neck and applying pressure to the extent that she experienced difficulty breathing or speaking. In concluding the assault on the VICTIM, the DEFENDANT struck her in her left eye with an unknown object, resulting in bruising to the immediate area. The DEFENDANT then fled the VICTIM'S home on foot. Photographs were taken of the bruising to the VICTIM'S face and she provided a sworn written statement, attesting to the altercation.

As the DEFENDANT is transient, his whereabouts are unknown, though it is believed that he remains within the Waldo community. The DEFENDANT has a prior conviction for BATTERY under court case number 04-2019-MM-0000744-MMAXMA with a conviction date of September 21st, 2020. In the course of his actions the DEFENDANT intentionally and maliciously stuck the VICTIM against her will, knowingly and intentionally impeded the VICTIM'S ability to breathe through his application of external pressure to her neck, and threatened to kill the VICTIM with a firearm, causing in her a well-founded fear that such violence or harm was imminent. The DEFENDANT has been charged with BATTERY, SECOND OR SUBSEQUENT OFFENSE FSS 784.03(2), DOMESTIC BATTERY BY STRANGULATION FSS 784.01(2)(a), and AGGRAVATED ASSAULT; DEADLY WEAPON FSS 784.021(1)(a)
