
PROSECUTIVE SUMMARY
They were in the parking lot and the Def and Co-Def approached them from behind. The Def attacked the Vic by punching her in the face and throwing her to the ground causing injury to the Vic. When the Wit attempted to intervene and stop the Def's attack on the Vic, the Co-Def then grabbed the Wit and forcefully restrained her so that she could not move. The Vic sustained bruising to her left eye, a bloody abrasion to her left elbow, bloody abrasion to her right hand knuckles, and a bloody abrasion to her right knee due
