Between 8/07 - 8/12, the DEF used his known phone number of 352-534-9514 to send the VIC over 30 repetitive threatening messages which caused the VIC to block him. The DEF then used a different phone number 352-359-1064 to send another 200 repetitive threatening messages to the VIC. The DEF demonstrated the same behavior and made the same jealous statements towards the VIC's boyfriend from both numbers to the VIC's phone [redacted]. The DEF would repetitively tell the VIC he is coming over her home [redacted] and her job ([redacted] Circle K) and threaten harm and death to [redacted].

her boyfriend. The DEF's actions have caused the VIC to block his previous numbers and change her own phone number. The DEF has shown a fixation on the VIC and has used her association with her boyfriend to placed her in severe distress and fear of her safety for no legitimate purpose. The DEF has shown a credible threat to want to cause her and her boyfriend harm  
On 8/07 at 1731hrs, DEF messaged VIC from his px. 534-9514 and stated "you on his side that nigga, everytime I see him, you need to be ready" and "I knew that car here [boyfriends car], I'm up here all night till you get off work," and "nigga you supposed to come out that door." The VIC said she observed the DEF in the parking lot of the Circle K while she was at work and called 911 for help but the DEF fled the area, incident #080724-0681. I later observed the DEF on recorded surveillance video during this timestamp waiting in the parking lot of the Circle K ( [REDACTED] ) and again inside the store staring at the VIC who was working at the register without being a customer.  
On 8/08 at 1331hrs, DEF messaged the VIC from px. 359-1064 and stated "well just tell that nigga I see him it's on." The VIC replied back "I don't want to see you again." DEF stated at 1322hrs "u bout to get a surprise of a lifetime."  
On 8/09 the VIC returned home from work and heard a knock on the front door [REDACTED] at 1400hrs but the subject left. Then at 1517hrs, the DEF messaged the VIC and stated "I'm trying to come see you, make time for me today cause I want to see you." DEF continued to state at 1930hrs "can I please come chill with you tonight," at 2010hrs "hey talk to me," at 2100hrs "about to come to your job, you know how I feel and how

I`m gonna react." The VIC replied back to the DEF and told him "you constantly threaten my peace, I`m done with you."  
  
PROSECUTIVE SUMMARY - CONTINUED  
On 8/10 at 0049hrs, the DEF continued to repeatedly send the VIC malicious messages and stated "I`m coming to see you, I`m chilling until that nigga not gonna take my spot." The VIC replied back "no you`re not, so leave me alone." The DEF stated at 0056hrs "you just trying to keep me from coming round there, I`m done trying to ask you, I`m coming after this nigga so [either] jail or dead, I be there tomorrow. The VIC said her several roommates kept the front door unlocked while she was home all day at [REDACTED] Then at approx. 1419hrs, the VIC observed the DEF standing inside her house near the stairwell and yelled for him to leave which he fled the property prior to LEO arrival, incident #081024-0432. I later took photos of the home and the stairwell.  
  
Then on 8/12 at 2039hrs, the DEF arrived at the VIC`s job again at [REDACTED] and stared at her from the outside window. The DEF fled the property as the VIC called 911, incident #081224-0862. I later observed the DEF on recorded surveillance video during this timestamp waiting in the parking lot of the Circle K [REDACTED] without being a customer and raising his hands in the air at the VIC. The store camera also recorded me arriving to the store in my police cruiser as the DEF passed by me on his bicycle and fled the area.  
  
The DEF was known to travel on a bicycle and frequent the Grace Market Shelter but could not be located. The VIC provided the DEF`s information and I positively I.D. him by his DAVID and RMS photo. I submitted a sworn complaint charge for aggravated stalking into GPD Records.
