The defendant is presently charged with a dangerous crime, there is a substantial probability that the defendant committed such crime, the factual circumstances of the crime indicate a disregard for the safety of the community, and there are no conditions of release reasonably sufficient to protect the community from the risk of physical harm to persons.
- 3. The Defendant did commit a sexual battery upon a person over the age of 12 and under the age of 18. The facts contained in Attachment A, the mittimus of Ofc. George Connolly are incorporated and relied upon for this motion.
