**MOTION FOR PRETRIAL DETENTION**

COMES NOW the State of Florida, by and through the undersigned Assistant State Attorney, and moves this honorable court to enter an Order detaining the Defendant in custody pending a final hearing on Pretrial Detention, and sets forth with particularly the grounds and essential facts, as follows:

1. The Defendant has been arrested for an offense for which detention may be ordered under §907.041, Fla. Stat., to wit: Sexual Battery
2. The State will show that there is a substantial probability that the defendant poses the threat of harm to the community. The defendant is presently charged with a dangerous crime, there is a substantial probability that the defendant committed such crime, the factual circumstances of the crime indicate a disregard for the safety of the community, and there are no conditions of release reasonably sufficient to protect the community from the risk of physical harm to persons.
3. The Defendant did commit a sexual battery upon a person over the age of 12 and under the age of 18. The facts contained in Attachment A, the mittimus of Ofc. George Connolly are incorporated and relied upon for this motion.
  - a. The Defendant is a pastor of a church in Tallahassee, Florida who along with juvenile members of the church travelled to Gainesville, Florida for the anniversary of a charge.
  - b. The Victim is the [REDACTED] of the Defendant and a member of the church.
  - c. The Defendant forced his [REDACTED] in her [REDACTED] inserted [REDACTED]



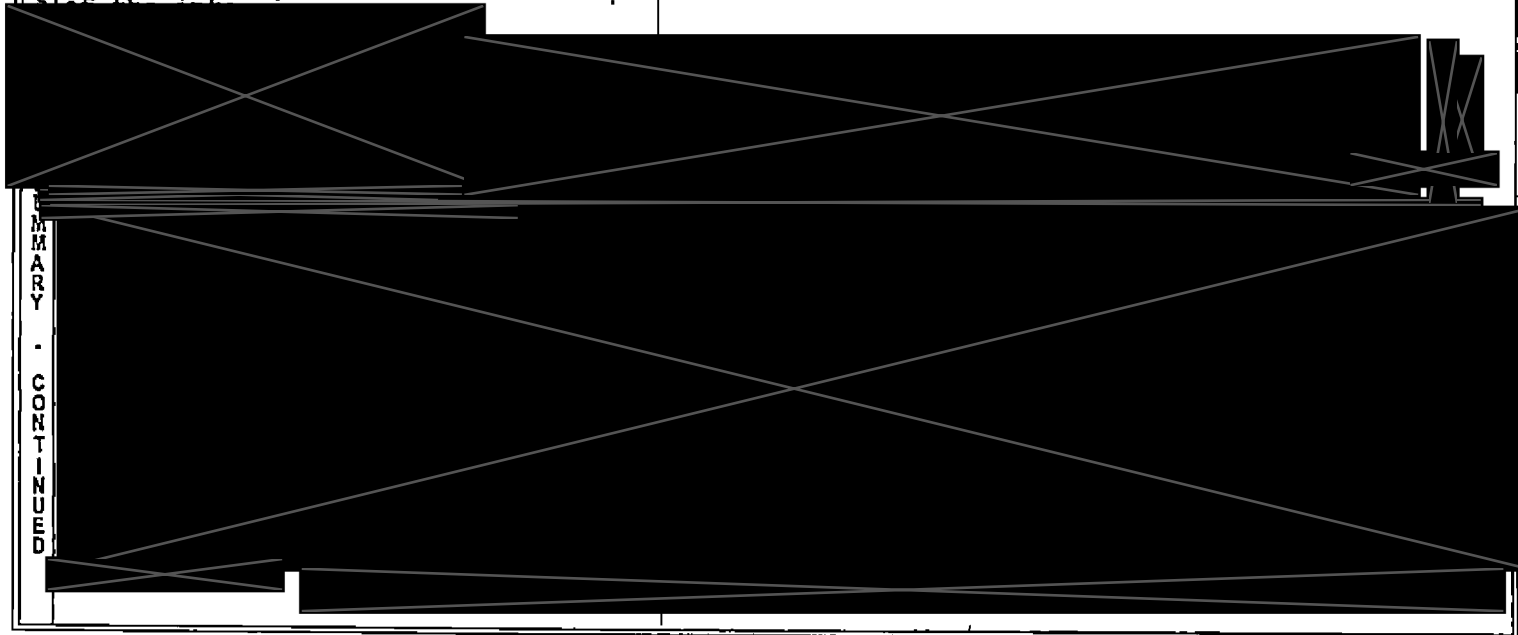

PROSECUTIVE SUMMARY CONTINUED

On 07/20/24, in the afternoon, Vic1 told Wit1 that Def1 had sexually battered her. Def1 entered the room shortly after. In front of Def1 and Vic1 Wit1 confronted Def1 about the sexual battery. Def1 asked if things could be fixed. Wit1 said no, Def1 then asked to be left alone with Vic1 to talk to her. Wit1 said no.

Def1 was on scene at the residence. He was transported to a CID interview room in which I spoke to him. Post Miranda, Def1 denied touching Vic1 at all, sexually or otherwise. Def1 initially denied Vic1 going to Gainesville with him on late Friday, early Saturday. Then I asked again who had been with him, which he stated his niece (Vic1) had come as well. I asked Def1 where the children slept. He stated in their own separate rooms while he slept in the master bedroom. I confronted Def1 on this information. Def1 relented and stated that Vic1 had gone to his room, but did not sleep there. I again confronted Def1. Def1 stated that Vic1 did get into his bed with him. Def1 stated that he did not touch her, that she got closer to him while he tried to sleep but that was it. Def1 then stated that she left and did not sleep there, but did not specify why. The only thing Def1 was able to say in reference to her leaving was that she went to get water/tablet and did not return.

I returned to the residence and spoke with Wit1 after I had spoken with Def1. Wit1 stated that she confronted Def1 with Vic1. Def1 never admitted to sexually battering Vic1. Later when it was just Wit1 and Def1, Wit1 again confronted Def1. Def1 only apologized for the situation and for his role in putting them there. He made no
