Probable Cause

On August 7, 2024 at 2313hrs, I responded to a BURGLARY OF A RESIDENCE at [REDACTED] SIERRA DAWN PARRISH is the DEFENDANT. [REDACTED] is VICTIM 1. [REDACTED] IS VICTIM 2. All will be referred to as such in this affidavit.

The DEFENDANT arrived at VICTIM 1's residence and made attempts to get in via the front door key entry pad. The DEFENDANT's code was unsuccessful. The DEFENDANT went around to the rear of the home and attempted to make entry, but was unable to. The DEFENDANT went back to the front of the residence. VICTIM 2 opened the door, and VICTIM 1 and VICTIM 2 advised the DEFENDANT that she needed to leave. THE DEFENDANT entered the threshold of the residence, where she stood and a verbal altercation ensued between her and VICTIM 1 and VICTIM 2. The DEFENDANT was in possession of an Amazon box that she threw down and proceeded to walk into a bedroom, near the garage. Once inside the bedroom, the DEFENDANT shut the door. A few moments later, the DEFENDANT exits the bedroom and goes into the garage. VICTIM 1 and VICTIM 2 follow the DEFENDANT into the garage.

At some point while in the garage, the DEFENDANT retrieves the garage door opener, exits the garage and gets into her vehicle. Once inside of her vehicle, the DEFENDANT places her vehicle, a 2020 BMW bearing FL tag RAJZ84, in reverse. The DEFENDANT then accelerates toward VICTIM 2, who was standing in the garage, recording the entire incident. The DEFENDANT places her vehicle in reverse again, but remained in the driveway. The DEFENDANT gets out of her vehicle, walks towards VICTIM 1 and began battering him. While VICTIM 2 attempted to break up the physical altercation, VICTIM 2 and the DEFENDANT engaged in a physical altercation.

The DEFENDANT left the scene prior to LEO arrival, but was apprehended a few miles away.

Post Miranda, the DEFENDANT stated she and VICTIM 1 have been in a dating relationship for approximately 2 years, but it ended on Friday (8/2/2024). The DEFENDANT also stated that she had a key to the residence, as well as a garage door opener, but that she did not reside at the location. The DEFENDANT said that she was battered by VICTIM 1 and VICTIM 2.

The DEFENDANT entered the residence owned by VICTIM 1. At the time of entering the residence, the DEFENDANT committed a battery upon VICTIM 1 and VICTIM 2.

The DEFENDANT intentionally and unlawfully threatened by act, to do violence to VICTIM 2, by accelerating towards VICTIM 1 with her vehicle. At the time, the DEFENDANT appeared to have the ability to carry out the threat. The act of the DEFENDANT created in the mind of VICTIM 2 a well-founded fear that the violence was about to take place. The assault was made with a deadly weapon (DEFENDANT's vehicle).

The DEFENDANT is charged with BURGLARY WITH BATTERY x 2 (810.02.2A F.S.S), and AGGRAVATED ASSAULT WITH DEADLY WEAPON W/O INTENT TO KILL (784.021 F.S.S.).
