and made contact with Vic2. OFC Roberts then responded to

Vic2 stated that the male with her was her boyfriend, and that he picked her up from her house at approximately 0745 hours after her father threw her to the ground, and then kicked her three to four times. OFC Roberts did not observe any injuries on Vic2.

Vic2 stated that her father, Def1, had followed her into the laundry room, and stated "hey bitch". Vic2 stated that she attempted to block the laundry room door to prevent her father from entering. Vic2 stated that the door to the laundry does not lock and her father pushed his way in. Vic2 stated that once he was in the laundry room Def1 began yelling at her then grabbed her and pushed her to the ground where he then kicked her. Vic2 stated that her mother Vic1 then came in and attempted to stop Defl. Vic2 stated that Defl then began hitting Vic1.

OFC Roberts separated her from Defl. While asking Vic1 about Once Vic1 arrived at the incident in the laundry room, Vic1 appeared to be hesitant about answering any questions. Vic1 took 30 seconds to a minute, while appearing spaced out as if attempting to think of a response. Vicl's hesitation appeared to be a result of fear. Vicl then stated that nothing physical occurred between Vic2 and Def1, and that she stepped in between the two of them to prevent anything from happening between them.

OFC Roberts then spoke with Defl, who after post Miranda warnings, stated Def1 stated Defl stated Def1 stated Def1 Def1 stated Def1 denied Def1 stated Defl denied

OFC Roberts then spoke with Vic1 again who stated that she got in between Vic2 and Def1 because she wanted to prevent anything physical occurring between the two of them. Vic1 stated that she did not know if Defl's actions were to just scare Vic2 or to cause harm to her. Vic1 stated that Vic2 slipped and fell behind the laundry room door as she was attempting to run away.

On Saturday, 09/07/2024, at approximately 1624 hours, OFC Spaulding was dispatched to in reference to a DCF Investigation which was generated from OFC Robert's investigation documented in GPD CR 02-24-013136.

There have been multiple reports made to DCF in OFC Spaulding met DCF CPI at reference to Def1's abusive behavior toward his daughter, Vic2, and her mother, Vic1.

Vic2 told CPI and OFC Spaulding that she ran away from home because Def1 kicked her multiple times

after getting mad about her wanting to go to a football game. Vic2 stated that she tried to barricade herself into the laundry room, which doesn't have a lock. Def1 forced his way into the room and kicked Vic2 multiple times. Def1 also hit Vic1 in the face with an open hand when Vic1 tried to intervene.

Vic2 stated that Def1 has been physically abusive to her and Vic1 for years. Vic2 told CPI that she does not feel safe at home and does not want to go back.

On 09/07/24, at approximately 0940 hours, I met with Vic1 and Def1 in GPD's east parking lot in reference to CR 24-13136. OFC Leibrandt was with me.

I asked to relay the events of Vic2 being found with her boyfriend in the parking lot to present
time. Def1 spoke about Vic2 and her boyfriend driving away, and LEO assisting in returning Vic2
to Vic1 and Def1. Def1 stated
Vic2 was saying she was going to a football game that night. Vic1
said no. Vic2 stated she would be going anyway. Def1 then approached Vic2, grabbed her by her
shirt, and told Vic2 that she was "acting like a bitch". Def1 stated

He stated After this
statement he corrected himself and said Vic2 then ran out of the
laundry room, and out the front door. Def1 and Vic1 attempted to look for Vic2 but could not find
her.

Throughout Defl relaying this information I kept my focus on Vicl. She looked uncomfortable and nervous. Vicl would not speak unless prompted by Defl, and anytime I tried to speak with her Defl would eventually interrupt our conversation. At some point I managed to separate Defl and Vicl. I explained to Vicl that I pulled her aside because her demeanor was reminiscent of someone being abused. She didn't look surprised or offended by this. I asked her about the laundry room incident. Vicl only stated that Vic2 did not yell. She stated that Vic2 speaks with conviction and confidence. Vicl continued and stated she was just speaking with Vic2, not arguing. Vicl then began talking about how she raised Vic2 to be the opposite of her. She wanted Vic2 to be confident and outspoken, to be able to advocate for herself without fear.

After speaking with Defl and Vicl, I drove to to make contact with Vic2. I was not aware of OFC Roberts' report until my arrival to Vic2's location. I searched CAD history to establish a timeline and include as much information as possible to my report, in doing so I saw a Domestic Battery call. This call was OFC Roberts' investigation.

It appeared likely that there was active domestic violence in the home, so I asked Vic2. She stated there was. She continued that Def1 has abused everyone in the home physically and verbally. This included her 24 and 21 year old brothers. Vic2 provided many instances of abuse for each family member. A recent incident was on Thursday, 09/05/2024. Vic2 stated she was woken from her sleep due to yelling. She witnessed Def1 yelling at Vic1 while Vic1 tried to defuse the situation. Vic1 walked into the kitchen and Def1 followed. Def1 backed Vic1 into a corner while yelling and then struck her face with a closed fist. Vic2 immediately went to Vic1 and removed her from the situation, and out of the house. Vic2 asked Vic1 where Def1 had hit her. Vic1

stated Def1 had just grazed her face. Vic2 also talked about the incident that occurred in the laundry room. Vic2 stated that she was getting ready for school, around 0730 hours, and was in the laundry room. Vic2 was talking to her mother, and stated she had a ticket for a football game that night. Vic1 said she was not going and Vic2 stated she would be going and no one would stop her. Vic2 heard Def1 yell "hey bitch" and saw him coming towards her. Vic2 closed the door and braced herself against it to keep it closed; because the door cannot lock. Def1 pushed the door open and threw Vic2 on the ground. Def1 then kicked Vic2 on the right side of her body; striking her stomach and upper thigh. Vic1 tried to get between them and Def1 swung a closed fist back to strike Vic1. Def1 then left the laundry room. This gave time for Vic2 to get up and run out of the house.

On 09/08/24, at approximately 0909 hours, I met with Vic1 and Def1 in GPD's east parking lot in reference to CR 24-13136. I pulled Vic1 aside while Def1 spoke with OFC Leibrandt and OFC Spaulding.

I explained to Vic1 that I would be arresting Def1 due to him hitting Vic2 in the laundry room. Vic1 did not look surprised, she remained quiet and was focused on listening to me. I further explained that I wanted to speak with her because Vic2 had disclosed Def1 physically and verbally abusing the entire family for years. I specified an incident Vic2 relayed to me about Def1 pulling out hair from the back of Vic1's head. Vic2 stated that a noticeable bald spot was left. I asked Vic1 if there was still a bald spot, she sighed and stated that there are short hairs now. I asked Vic1 once again what had happened in the laundry room the morning of 09/06/24. Vic1 stated that everything happened so fast. She stated that she was speaking with Vic2 about a football game Vic2 wanted to go to. Vic2 stated she was going to the football game, that no one could stop her. Vic1 specified Vic2 was not yelling or being aggressive. Def1 then angrily started moving towards the laundry room. Vic2 tried to close the door, and hold it closed, as the lock is broken. Def1 then pushed the door open. Vic1 stated Vic2 then slipped and fell behind the door. Vic1 continued that she then got between them before something physical occurred. She denied being struck, or seeing Vic2 get struck.

I began to implore Vic1 to tell me about the incidents of domestic violence in the home, if not, at least of the incident Def1 pulled out her hair. Vic1 paused many times during our conversation, becoming tearful at moments. She stated she was afraid to disclose because then Def1 would have nothing, and that's "when someone is their most dangerous". I continually tried to explain resources that would be given with the arrest, but Vic1 again was focused on Def1 getting out of jail and coming to harm her and her family. She relayed that she just wanted to get her kids out of the home, so she too could get away. Vic1 relented at the end of our conversation and stated she would disclose everything when her daughter returned home.

I went back to Defl and read him his Miranda Rights from a department issued card. Post Miranda, Defl

I placed Defl in double locked, fitted handcuffs. Prior to transport to ASO DOJ, Defl stated he needed EMS. EMS was called, and responded. He was transported to North Florida Medical Center, precautionary.

I asked OFC Spaulding if she would speak with Vic2 to have her return home, as Vic1 stated she was only comfortable making a full disclosure at that time. OFC Spaulding made contact with Vic2 at OFC Spaulding informed Vic2 that Def1 had been arrested for the physical abuse he committed against her and Vic1 on 09/06/2024. Vic2 wanted to know what his bond was and when he was getting out. Vic2 was adamant that she was afraid to be in the home until she knows Def1 will not be able to come back and harm them.

Vic2 elaborated on the abuse between Vic1 and Def1. She advised that there have been multiple incidents where Vic1 has taken Vic2, and they have left for a few days to escape Def1. One time was when Vic2 was in 7th grade. Vic1 came home upset and advised that Def1 pulled her hair out in the car. Vic1 and Vic2 then left the home for 2 days and slept in the car because they were fearful of Def1. The last time they left was last September. Def1 took Vic1 to an unknown location and beat her up. Vic1 came home and had visible injuries to her face and head. Vic1 went to North Florida Millhopper to get medical care due to the physical abuse. Vic2 advised that Vic1 has photos of her injuries from throughout the years. Vic2 also advised that Vic1 has been afraid to report things to the police because she is afraid that Def1 will send someone to kill them if he ends up going to prison.

While I watched Defl in the hospital, Defl was talking to himself. I was not responding or talking. During this he abruptly brought up an incident in which Vicl was in the kitchen. Defl stated

I had never asked Defl about an incident in the kitchen. The only incident I had ever questioned him about was the incident in the laundry room.

Defl was identified via FL DL.
