then touched himself in front of the Ring camera outside the apartment door. The male left and then came back shortly after and continued to touch himself. He was wearing black pants, grey boxers, black shirt and black shoes.

Upon my arrival, I made contact with the victims ( [REDACTED] and [REDACTED] ) at the apartment. In summary they stated the following; they had just arrived to the apartment before they called 911. When they got to the front door of their apartment, they observed the offender (later identified as Tyrall Evans) touching himself under a tree on the ground floor. They then went inside the apartment. Shortly after, [REDACTED] received a Ring notification that someone was at her front door. [REDACTED] and [REDACTED] then observed Evans touching himself while facing the Ring camera. Evans covered his face with a pair of shoes while masturbating. Evans left and then came back and continued to touch himself before leaving again.

I then viewed the Ring videos with Ofc. Osborne. I observed Evans standing in front of the Ring video. He matched the description given by [REDACTED] and [REDACTED] to include a low fade haircut. I observed Evans to have his shirt pulled up while he was masturbating. I observed Evans to have a distinctive linear scar on his stomach. I also observed Evans clothing to have a McDonald's work shirt with the McDonalds emblem. The Ring videos showed that Evans left and then came back and continued to masturbate.

Ofc. Osborne canvassed the apartment complex and located Evans in the stairwell of building 10 outside apartment 1024. When Ofc. Osborne made contact with Evans, he appeared to be nervous and paced around. Evans also provided Ofc. Osborne his FL driver's license.

Ofc. Osborne called for backup and I responded to building 10. I observed Evans to match the description of the suspect in the Ring videos. I also observed that Evans changed his clothing, however he had on the same grey boxers. I explained that we were conducting an investigation. I asked Evans to lift his shirt to dispel my suspicion that he was involved. He was not compliant initially, but he eventually lifted his shirt. I observed Evans to have the same distinctive linear scar on his stomach from the Ring video.

I then told Evans to place his hands behind his back and I attempted to handcuff him. Evans pulled away from us and ran down the hallway. I yelled at Evans to stop, but he kept running. I then deployed my taser but it was ineffective as it did not make contact with Evans. Evans then fled through the parking lot where we lost sight of him.

The Resident in apartment [REDACTED] initially stated Evans lived there but she later denied that he lived there. She stated that Evans was her friend. She could not provide any personal information for Evans. She became uncooperative.

Ofc. Osborne made contact with a manager at McDonald's located at 3418 SW 34th ST. The manager confirmed that Evans worked at the location and works the 5pm-12am shift.

I sent a community request link to [REDACTED] to upload the Ring videos.

Evans was identified by his FL DL.
