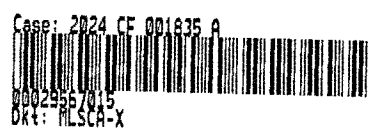

On that above date and time, the VIC (girlfriend) and DEF (boyfriend) dated for 1yr and resided together at [redacted] along with the VIC's daughter from another relationship (WIT). It was determined in the early morning hours on 4/16 between 0200 - 0400hrs, the VIC and DEF were in their upstairs bedroom in a verbal argument about the DEF spending his money and not paying his share of the bills. The VIC said the DEF did not like her talking back and the argument turned physical when the DEF pushed the VIC down onto the bed and used his hands to grab her neck and choke her to the point it restricted her airway. PROSECUTIVE SUMMARY	<p>stated "I couldn't breathe and I scratched at him everywhere to get him to stop." VIC stated the DEF let her up and she went downstairs to separate herself but the DEF followed behind her where the violence continued into the living room. The DEF began to pull on the VIC's clothes and body to get her off the sofa which caused scratches to her back. Due to the time lapse of the report, LEO observed healed scars from scratches along the right side of the VIC's back. The VIC stated the DEF then swung his left hand and struck her right eye in attempts to grab her hair.</p> <p>Later that same morning, the VIC received medical care at EPMC 9181 NW 39th Ave and showed LEO a clinic discharge document which referenced a contusion and swollen eye injury on 4/16 at 0820hrs. The VIC showed LEO a photo of the wooden headboard bedframe cracked and damaged. The VIC showed LEO text messages timestamped 4/16 1656hrs between her and the DEF in which the VIC stated "the bed is broken," and "you choked me until my eardrum popped, my eye is fu-- up and I have blurred vision." The DEF replied "the bed is not broken," "lets face it you don't want me, I have some fu-- up ways sometimes, I fu-- up in this relationship" and "If I want to hurt you, I could have I guess." The VIC wrote and signed a statement.</p> <p>The WIT (VIC's adult daughter) stated on 4/16 at approx. 0300hrs in the morning, the VIC and the DEF were yelling at each other and she later heard her mother screaming. The WIT then heard them both walk downstairs where she heard her mother scream again. As the DEF left the home, the WIT went downstairs to check on the VIC and observed deep visible scratches along the VIC's back in which she helped apply Neosporin ointment.</p> <p>DEF now resides separately at 2220 SW 34th ST #195 (Gardenview Apartments) where he was</p>

PROSECUTIVE SUMMARY - CONTINUED  
contacted and interviewed by LEO. Post Miranda, DEF denied any violence occurred on 4/16 nor in April. DEF denied damaging their bed that day, denied choking or hitting the VIC, and denied following her to the living room or hitting her in the eye. DEF said he believed the VIC reported this because he had her investigated for taking his money, see GPD CR 24-007313 on 5/14. The DEF was not wearing a shirt and LEO observed 3 x healed scratch marks along his right chest which appeared from someone's fingers. The DEF stated "I have old scratches all over my body" and denied the VIC scratched him.  
  
GPD Domestic Violence DET Connelly agreed probable cause was established that the DEF committed a count of battery and a count of battery by strangulation. On 5/25, I attempted to contact the DEF at his own residence and by his phone multiple times with no results. I positively I.D. the DEF by his DAVID photo and submitted charges for strangulation battery and simple battery into GPD Records.
