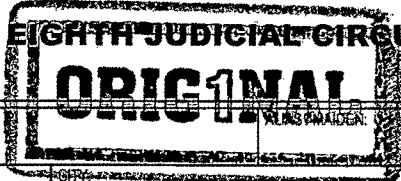

PROSECUTIVE SUMMARY CONTINUE  
She and Defl were arguing over money, and Defl's drug habits. During the argument Defl became angry and pulled Vicl out of the bed by her neck. Defl strangled Vicl for a while and during that time Vicl was not able to breathe normally. After a moment Defl released Vicl and began to punch himself. Defl stated that if Vicl calls the police she would also go to jail because he would tell police that she punched him. Vicl has Defl on video stating this.  
After Defl hit himself, Vicl tried to leave the room, but Defl grabbed her by her shirt and held onto her neck again and yelled, "bitch" at her. Defl again began to strangle Vicl to the point where she could not breathe normally, Vicl kneed Defl in his testicles causing him to let go. Defl again grabbed Vicl and pushed her against their bedroom fridge, again Defl grabbed Vicl's neck, this time Defl said, "I better leave before I kill you."  
As Defl was about to leave he noticed Vicl was recording and demanded Vicl give him the phone. Vicl would not give Defl the phone so Defl threw a broken standing fan at Vicl hitting her on her right shin bone. Vicl began to throw items at Defl until Vicl's daughter woke up. Her daughter did not see the fighting, but saw the destroyed room. When Vicl's daughter woke up Defl left the residence. The daughter did not hear anything since she was asleep, when she walked in their room to see what happened the argument stopped.  
Vicl took photographs of her injuries at this time, she took photos of her neck which had bruising, photo of her right shin which was bloody and had a large shallow gash and has video recordings of Defl yelling, screaming and of him saying he hit himself to get

Def1 does not confirm that he injured Vic1, but does admit that she deserves better and that he is sorry. Examples of this can be observed below:  
Def1: (There is more content to the message above that is cut off) Habit do the math it cost 160 for the stuff for the truck what left after that so I don't have a Habit it's no coke in my system lol"  
Def1: And I completely understand  
Vic1: U gave me 200..  
Vic1: Check was 456..  
Def1: Out of 438?  
Def1: 448  
(Vic1 sent photos of her injuries just prior to this exchange.)  
Vic1: Yea...I can do better  
Vic1: U gave me all that  
Def1: Yeah I know you deserve better you really do I'm sorry for everything so I have to be a man and let you go I'm going to miss you but it's best for you

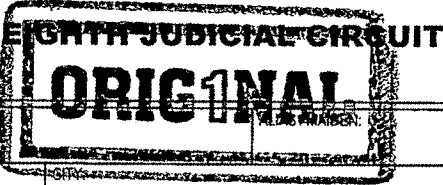

Def1 stated that if Vic1 calls the police she would also go to jail because he would tell police that she punched him. Vic1 has Def1 on video stating this.

After Def1 hit himself, Vic1 tried to leave the room, but Def1 grabbed her by her shirt and held onto her neck again and yelled, "bitch" at her. Def1 again began to strangle Vic1 to the point where she could not breathe normally, Vic1 kneed Def1 in his testicles causing him to let go. Def1 again grabbed Vic1 and pushed her against their bedroom fridge, again Def1 grabbed Vic1's neck, this time Def1 said, "I better leave before I kill you."

As Def1 was about to leave he noticed Vic1 was recording and demanded Vic1 give him the phone. Vic1 would not give Def1 the phone so Def1 threw a broken standing fan at Vic1 hitting her on her right shin bone. Vic1 began to throw items at Def1 until Vic1's daughter woke up. Her daughter did not see the fighting, but saw the destroyed room. When Vic1's daughter woke up Def1 left the residence.
