PROSECUTIVE SUMMARY - CONTINUED

The VIC stated that once the DEF was almost up against her and within inches of her face she shoved him back to get him away from her. The VIC stated that the DEF then punched her in the face with a closed fist knocking her down to the ground.

WIT1 stated that he observed the DEF throw the beer can at the VIC. WIT1 stated that he did not observe anything physical between the VIC and DEF. WIT1 stated that he turned around to go back inside his apartment and then when he looked behind him the VIC was laying down on the ground, seemingly unconscious.

WIT2 stated that she did not see the altercation, but exited her apartment after hearing the VIC yelling about being punched.

The DEF stated post Miranda Warning (from GPD issued card), that he threw the beer can off to the side and not at the VIC. The DEF stated that the VIC then started yelling at him and punched him in the face with a closed fist. The DEF stated that he then punched the VIC in the face, due to her hitting him.

I observed no injuries on the DEF.

I observed injuries to the VIC's left elbow. The VIC also complained of pain to her jaw.

I identified the DEF, VIC, WIT1 and WIT2 by their FL ID Card's.
