with being punched in the face multiple times.

Post Miranda, the DEF admitted to using the VIC's money to pay the rest of the rent however, he advised she knew about it and gave him consent. The DEF confirmed that he and the VIC were in an argument over the bills. The DEF initially advised the disagreement was only verbal. However, when confronted about the VIC's injury the DEF stated the VIC attempted to punch him once in the face but he blocked it. The DEF admitted to pushing the VIC onto the sofa but stated it was because she was holding him. The DEF then stated the VIC was standing in front of the door and he wanted her to leave him alone. He eventually admitted to hitting the VIC once in the face as he was attempting to leave the residence. The DEF denied knowing the VIC was the phone with 911. The DEF had no visible injuries.

The VIC and DEF's 4 year old son was home at the time of this incident but did not witness the actual battery.

The DEF and VIC are married, have been together for 11 years, share two children in common and currently reside together as a family. The VIC denied any previous history of domestic violence.

The DEF was positively identified by his Indiana ID.
