On the above date and time, the DEF was captured on traffic camera footage repeatedly hitting the VIC in the face and slamming the VIC into the ground. The VIC is a mentally disabled and vulnerable adult who has been diagnosed with Prader-Willi Syndrome. The DEF is the VIC's caretaker at the group home where the VIC lives.

On duty officers working the UF football game observed the DEF striking the VIC on the traffic camera and notified patrol officers to respond. The DEF told law enforcement that the VIC had become agitated and he was forced to physically restrain the VIC

because he kept running into traffic.

However, upon review of the traffic camera footage, the DEF can be viewed picking the VIC up by the arms and slamming his body into the sidewalk. Furthermore, the DEF is observed striking the VIC with closed fists in the torso, arms, and face.

This resulted in the VIC sustaining several small lacerations and bruising to his arms. In addition, the VIC's top lip was busted and he was bleeding profusely from his mouth.

Post Miranda, the DEF admitted to physically restraining the VIC. He did not admit to striking him repeatedly into the ground. The DEF's injuries are inconsistent with physical restraint and corroborate the traffic camera footage showing the DEF intentionally and repeatedly striking the VIC until law enforcement arrived.

The DEF was identified via his FL DL.
