battery. Ellis Houston and re currently married and residing together as a family unit, making this incident domestic in nature. Ellis is the DEFENDANT in this case, while is the VICTIM. Patricia's daughter, is the WITNESS in this incident.

The VICTIM advised that the DEFENDANT abruptly entered her daughter's room where she was sleeping. The DEFENDANT made statements about the VICTIM not coming to bed, and that he would see her in the morning. The DEFENDANT proceeded to hit the VICTIM in the area of her upper back/shoulder blade for no apparent reason, and then exit the room. Upon exiting the room, the DEFENDANT continued to yell and make statements such as "I'm going to kill this b*tch." The VICTIM advised that she was not hit hard enough for a mark to be left on her skin. However, she confirmed that the contact was unwanted and done for no apparent reason.

The WITNESS was also in the bed with the VICTIM at the time of the incident. The WITNESS, who was watching TV at the time, observed the DEFENDANT enter the room and hit the VICTIM on the back. The WITNESS stated that the DEFENDANT hit the VICTIM "hard enough for her to hear it." The WITNESS stated that the DEFENDANT then exited the room, and proceeded to make statements about killing the VICTIM.

Post-Miranda, the DEFENDANT admitted to entering the room, touching the VICTIM, and shaking her to get her attention. The DEFENDANT did not claim to do this in a malicious manner.

Based on consistent statements made by the VICTIM and WITNESS, investigation revealed that the DEFENDANT actually and intentionally touched or struck the victim against her will. The DEFENDANT intentionally caused bodily harm to the VICTIM.

The DEFENDANT is being charged with misdemeanor battery, in accordance with F.S. 784.03.

It should be noted that the DEFENDANT and VICTIM have an extensive history of domestic disturbations ASO has responded to 7 documented domestic disturbances (including 2 domestic batteries).
