PROSECUTIVE SUMMARY - CONTINUED  
impeded the VIC's normal breathing and blood circulation, during the altercation. The VIC advised that she felt like she was going to pass out. The DEF took his right hand and placed it over the VIC's mouth and nose. The DEF then pulled the VIC by the hair multiple times during the altercation.  
I observed the DEF batter and choke the VIC on video, due to the VIC having cameras in her apartment.  
I observed pictures of the injuries the VIC sustained during the incident, that were consistent with the information she provided in reference to this incident.  
The VIC positively identified the DEF by RMS Photo.  
Due to the DEF being in the ASO jail, I did not interview the DEF.
