a criminal offence on the [REDACTED] Henceforth referred to as VICTIM). The VICTIM and the DEFENDANT had been in an intimate relationship for nine months, classifying this incident as Domestic in nature.

Deputies responded to a battery that was occurring at The Crossings at Santa Fe Apartments located at 3205 NW 83 St, Gainesville, FL 32606. A witness had reported that a physical altercation was occurring at the location.

The DEFENDANT had been in an argument with the VICTIM over possession of the DEFENDANT's phone. During the course of the argument, DEFENDANT placed the VICTIM in a choke hold to gain control of the phone, causing injuries to the VICTIM's neck and back. The VICTIM was assessed by Emergency Medical Services and transported to a hospital for injuries consistent with strangulation.

VICTIM did express that she wanted to pursue charges on DEFENDANT.

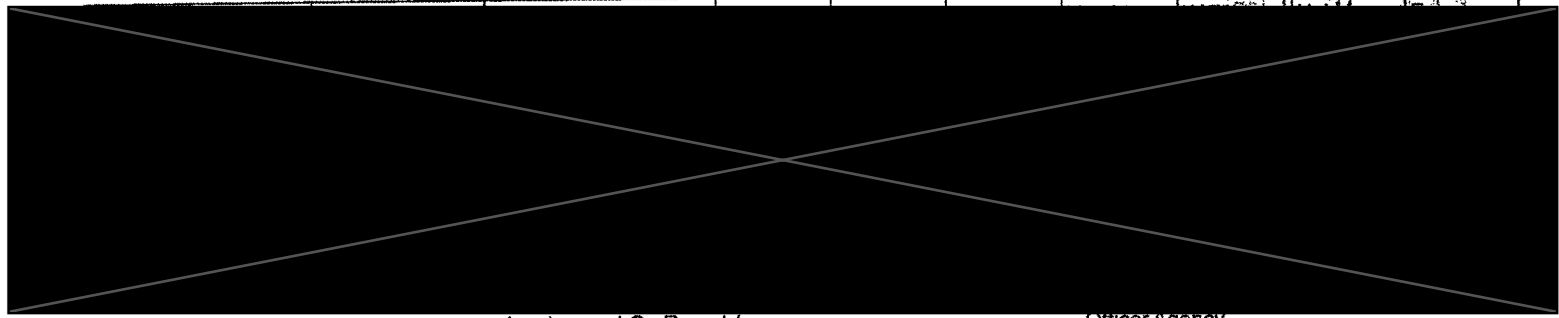
