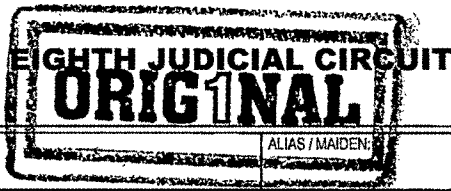

On 01/18/2024 at 0725 hours security cameras at Big Mills Cheesesteaks, 2111 NW 13th St, captured a subject arriving at the rear door of the business. The subject enters a code to a key lockbox and retrieves a key. The subject then uses the key to enter the business. Once inside the subject opens the cash drawer and steals \$1,196.91 in various bills. The subject then leaves out the rear door placing the key back into the lockbox.  
The WIT1 is the manager of the business and immediately identified the DEF as a possible suspect. The DEF is a former employee who was recently fired from the business. The

| <b>PROSECUTIVE SUMMARY - CONTINUED</b> | <p>WIT1 stated that the DEF knew the lock box location, code, and location of the money. The WIT1 stated that the DEF is a match to the physical build of the suspect in the video.</p> <p>On 08/15/2024 the DEF was arrested for a Domestic Battery, CR 02-24-011879. During this arrest, the WIT2 (the VIC in the Domestic case) revealed to officers that the DEF committed an Armed Robbery and a Burglary. The DEF was later charged with Armed Robbery of Smoke City, CR 02-23-020193. The Burglary that the WIT2 was referring to was this case.</p> <p>I, Det. Bunevich, showed WIT2 the video from Big Mills, The WIT2 identified the backpack and the clothing that the DEF was wearing during the burglary as his clothes. The WIT2 stated that the unique backpack belongs to the DEF's family and he has since returned it to him.</p> <p>The DEF was identified by his RMS photo.</p> |
