On 12/22/23 at approximately 2137 hours GPD patrol responded to a report of an armed robbery at 2107 NW 13th St (Smoke City). Surveillance video (with audio) showed the suspect enter the store brandishing what appeared to be a black handgun saying "I need money and weed, right now". The suspect placed a brown paper bag on the counter where the clerks placed money from the cash register and THC products into the bag. The suspect then walked out of the store with approximately \$600-\$800 cash and \$200 worth of THC products. The suspect was a black male wearing a green elf onesie with red trim on the end of the sleeves, pants legs, and hood. The hood of the onesie had a red ball at

the end. The suspect also had a black and gray backpack with black cord crisscrossed on the top and a large red/yellow logo on the bottom rear portion. The suspect had what appeared to be a black handgun and pointed it multiple times at both clerks throughout the robbery. The suspect also had a black watch and a thick ring with thin metallic bands around the outside and black in the center.
On 8/15/24 GPD patrol responded to 1324 NW 16th Ave (Georgetown Apartments) in reference to a domestic battery between the DEF and WIT 2 (GPD CR# 02-24-011879). During the investigation WIT 1, who is the mother of WIT 2, produced a green and red elf onesie costume and said the DEF was responsible for the robbery of a smoke shop months prior. WIT 1 added that she had seen the DEF wearing this costume in the past and that she had washed it for him. The costume was identical to the one seen in the surveillance video. The DEF also fit the build of the suspect in the video. The DEF also lives in close proximity of where the robbery occurred.
On 8/16/24 YA spoke with WIT 2, who is the DEF's girlfriend. WIT 2 said she did not know about the DEF being involved in a robbery. After being shown still frames from the surveillance video WIT 2 produced a backpack belonging to the DEF that was identical to the one seen in the surveillance video. The backpack was gray and black, had a black cord crisscrossed on the top and had a large red/yellow "Food Dietary Services" logo in the bottom rear portion. WIT 2 said the DEF did not own any real firearms but did have a BB gun. WIT 2 then produced a BB gun from a clothes hamper that was identical to the presumed handgun seen in the surveillance video. When shown a photograph of the suspect's watch WIT 2 said the DEF owns a similar watch but she could not find it. WIT 2 added that the DEF came into a large amount of money in December but she believed that

the DEF won the Lottery.

At the time of the DEF's arrest for domestic battery he was wearing a thick ring with silver trim on the outside and black in the center, similar to the one seen in the surveillance video.

Post Miranda the DEF denied any involvement in the robbery. The DEF did identify the handgun given to YA by WIT 2 as belonging to him. After speaking with the DEF his voice was consistent with the suspect's voice in the surveillance video.
