DEF then sent the VIC several text messages threatening to come to her home. Based on previous physical violence incidents, the VIC was in fear that the DEF would come to her home and attack her.

On 06/21/2017, from the hours of 1130 to 2100, the DEF sent the VIC 33 text messages. In the messages, the DEF stated that Gainesville was a small town and that he would find her and do things to her before contacting the Police himself. The DEF also called the VIC a, "Bitch," and a, "Retard," and repeatedly insulted her.

On 06/13/2017, the VIC told the DEF to have no more contact with her. On 06/21/2017, the VIC told the DEF three times via text message to stop contacting her.

The VIC stated that she was so scared of the DEF that she did not want to leave her family at home by themselves for fear that the DEF would show up when she was not home.

Post Miranda, the DEF stated that he intentionally sent the VIC threatening text messages because he was angry at her for ignoring him.
