My investigation revealed that the DEFENDANT and the VICTIM were conversing on the phone as the VICTIM was coming back home. The DEFENDANT was upset that the VICTIM had been out with friends and wasn't able to pick him up from work. During their phone conversation, the DEFENDANT then began to send threatening messages in the text thread to the VICTIM, that read "choke your pussy ass tonight", "Nigga gone damn near kill you", and "death now". The VICTIM became terrified that the DEFENDANT was going to harm her. The VICTIM then parked at a nearby grocery store and contacted law enforcement. The VICTIM then decided that she wanted to go home and wait for law enforcement there, so she left the grocery store and arrived home. The VICTIM remained in her vehicle as she waited for law enforcement.

Approximately 10 to 15 minutes later, the DEFENDANT exited the apartment brandishing a silver-bladed, black handled knife, as he approached the VICTIM's vehicle. The DEFENDANT ordered the VICTIM to get out of her vehicle, and when she refused, the DEFENDANT became upset and began striking the VICTIM's vehicle door panel and window with the sharp blade of the knife, in an attempt to gain access forcefully inside the VICTIM's vehicle. The VICTIM then had a well-found fear that if she remained at the location, she would be fatally harmed by the DEFENDANT. The VICTIM then left the location at a high rate of speed in order to not be harmed by the suspect.

The VICTIM was visibly shaking and actively sobbing when I approached her. The VICTIM's vehicle had a fresh cut across the vehicle door, that was consistent with a sharp blade striking it's surface. The Damaged was estimated to be approximately \$500.

The DEFENDANT was apprehended later at their residence by on scene deputies.

As deputies arrived on scene, the defendant spontaneously stated that he was in possession of a box cutter knife that he recently obtained from work. This was verified as a silver box cutter knife, as described by the victim, and was located in the defendant's pocket. However, post Miranda, the defendant denied ever brandishing a knife at the victim. The defendant advised that he exited his apartment and observed the victim sitting inside of her vehicle in the parking lot. He claimed that the victim had her window rolled up at the time as he walked towards her vehicle. The defendant stated that there was no verbal argument between him and the victim, and that all of their conversation leading up to the incident occurred via text. The defendant was asked how the victim would have knowledge of him being in possession of the knife without ever seeing it. The defendant maintained that the knife was never taken out of his pocket, and that the victim has knowledge of him frequently carrying that knife. He stated that he constantly carries and uses the knife. The defendant's statements post-Miranda were inconsistent with his initial spontaneous utterance. Furthermore, the defendant attributed the damage to the victim's car to a recent car accident."

Based on my investigation the DEFENDANT is being charged with criminal Mischief, aggravated assault with a deadly weapon, written and spoken threats, and armed attempted burglary on a conveyance.
