On 09/14/2024 at 21567 NW 172nd Road at approximately 0800 hours Willie T. McMillan did commit the offense of aggravated assault (domestic) and false imprisonment on the victim, Kathryn Scanlon. This incident was video recorded on the victims cell phone, a majority of it is audio only. Willie McMillan and Kathryn Scanlon have a child in custody, thus making this incident domestic in nature.

Willie got into the victim's vehicle during their child custody switch and said, "If you could kill me, would you?". He then pulled out a silver handgun and placed it on the

center console, the victim said "will you not" and then Willie said "if you could shoot me, would you shoot me? I`m asking you a question, if you could shoot me, would you shoot me? Cuz it seems like you have that much hate for me." The victim then said "you need to pick that up and you need to get out of my car. I need to go to work." Willie asks her to answer the question again and she says, "I`m not talking to you when there is a gun sitting between us". During the conversation Willie was upset that the victim speaks to people in the same town he lives in and stated it was his concern because she is his child`s mother. The victim stated again that she needed to go to work. Willie then asked "do you hate me, Katie? I`m about to let you go to work, do you hate me?" After a few seconds of silence, Willie says "I`ve been having bad thoughts, I`d rather for you to pick that up and squeeze the mother fucking trigger, than for me to get out and walk out this mother fucking car... I would rather you pick that mother fucker up and shot me." Willie then picks up the gun, gets out of the car and shuts the door. The video then shows Willie walking away from the vehicle wearing a white t-shirt, camo pants, with red dreads and a black glove on his right hand. Willie is also seen in the video removing his right hand from his right pants pocket as he walks away.
Willie placed a well-founded fear in the mind of the victim that an act of violence was about to take place by producing a silver handgun and not allowing her to leave. Willie had the opportunity to commit such offense because he produced the handgun. During this act, Willie also would not allow the victim the leave, even though she said several times "I need to go to work", the victim did not feel as though she was free to leave. By this act, Willie confined the victim to her vehicle and in doing so, used the threat of a weapon to keep her there.

PROSECUTIVE SUMMARY - CONTINUED
Contact was made with Willie at the incident location. Post Miranda, Willie did not agree to speak with law enforcement. When explained what the charges were, Willie stated that there was no gun. I asked Willie if he consented to a search of the trailer where he resided and he responded with "yeah, if you want to". The trailer and the area of which it occupied, was searched and a yellow bag was located on the southside of the trailer in a trash can. Inside this bag was a small silver handgun (exactly described by the victim). The handgun is a Lorcin .380 serial number 349903. There was also twelve (12) rounds of 9mm ammunition in the same yellow bag.
A criminal history was completed and is 2004 in the state of Philadelphia, Willie was convicted of a felony reference PHILADELPHIA PD - C0759311.
With the above information, Willie McMillan is being charged with the following: FSS 784.021.a aggravated assault with a deadly weapon (domestic), FSS 787.02 false imprisonment, and FSS 790.23.a
